Re: FY25 Revaluation Funding Request

In order to comply with the attached City Council Resolution of June 16, 2021 and Maine property tax law, I would like to initiate the revaluation process of the City for assessment purposes. The resolution recommended that *the City Tax Assessor and the City Manager, as necessary, conduct ongoing work to support City wide revaluations every five (5) years, and that sufficient funds to support such city-wide revaluations be authorized and appropriated.* Additionally, State property tax law guidelines require municipalities to be between 70% and 110% of market value. The last revaluation was completed in 2021. The market value to assessed value certified ratio for FY25 will be 89%, and is projected to be 82% for FY26 and 74% for FY27.

It is important to note that a declining assessment ratio is an indication of a lack of equity in property tax assessments. A lower certified ratio for the coming tax years will also have several impacts including reducing the amount residents receive from the Homestead, Veterans and Blind Exemption programs. For example, in FY25, a \$25,000 Homestead Exemption will now only be valued at \$22,250.

In order to comply with the requirements above, we would need to start the revaluation process in 2024. The anticipated completion date would be the summer of 2025, and implementation would be in FY26. This work would be done with current staff, a contracted revaluation company, and updated imagery.

Our contract with the revelation company would be a multi-year reassessment contract, which would be conducted every 2 years until 2031. This will preserve equity in tax assessments through the period of the contract versus the current practice of no formal revaluation timeline.

A revaluation would more specifically include:

- Full statistical analysis to create current value market modeling and new cost and depreciation tables;
- Residential, Commercial and Industrial valuation;
- Public information and support throughout the entire project; and
- Appeals support.

In addition to a full real estate revaluation, I would also recommend a separate Personal Property revaluation. Personal Property is a State imposed tax on business equipment that every business in the State of Maine is subject to. The State has established a reimbursement program and an exemption program to aid businesses in recapturing or exempting some of the Personal Property taxes.

The total taxable value of Personal Property reported for the 2023 tax commitment was \$214,318,005. The total exempt value was \$480,201,080 with a reimbursement value of \$252,201,607. I outline these amounts to indicate the significant value of Personal Property.

The Assessing Office is responsible for the inventory and depreciation of all business equipment located within the city to establish a taxable value. The current process of sending the annual declaration forms to collect and value Personal Property would be significantly aided by a full Personal Property revaluation. A contractor would conduct a complete street canvassing of the city to identify new businesses and list the equipment of existing businesses. The cost estimate for a Personal Property revaluation is \$60 per account or \$192,000.

**RESOLUTION RECOMMENDING INCREASED FREQUENCY OF PROPERTY
REVALUATIONS FOR THE CITY OF PORTLAND**

WHEREAS, the City Council of Portland, Maine, uses assessed property values in order to appropriately levy and collect property taxes; and

WHEREAS, the Mayor and the City Council recognize and appreciate the fact that an important and primary role of the City of Portland Tax Assessor is to determine the just value for all residential and commercial real property in Portland, which helps to ensure that it is able to appropriately levy and collect those property taxes and that the burden of those taxes is shared fairly and equally among all property owners within the City; and

WHEREAS, Maine's Constitution requires that "[a]ll taxes upon real and personal estate, assessed by authority of this State, shall be apportioned and assessed equally according to the just value thereof." Me. Const. art. IX, § 8; and

WHEREAS, Maine state law similarly provides that "all property shall be assessed at the just value thereof in compliance with the laws of the State." 36 M.R.S. § 201; and

WHEREAS, Maine Constitution's Constitution further requires that "[w]hile the public expenses shall be assessed on estates, a general valuation shall be taken at least once in 10 years," Me. Const. art. IX, § 7; and

WHEREAS, prior to the current revaluation, the City of Portland's two most recent revaluations occurred in 1991 and 2006, respectively, thereby establishing a fifteen (15) year interval between each such general valuation; and

WHEREAS, Maine law additionally requires that "[a]ll municipalities . . . shall achieve the following minimum assessing standards . . . a 70% minimum assessment ratio . . ."; and

WHEREAS, the Maine Revenue Services determined Portland's 2021 assessment ratio to be 66 percent; and

WHEREAS, when the real value of properties are either undervalued or overvalued as a result of infrequent or delayed evaluation, one of the results is that owners of more

valuable properties experience the equivalent of a tax break, while owners of less valuable properties pay a relatively higher price for the same public services; and

WHEREAS, by failing to frequently assess property, government is exacerbating the large and growing inequalities in the distribution of wealth and income; and

WHEREAS, the value of real property is constantly changing due to factors including, but not limited to, location, market demand, the age and physical condition of a neighborhood, and the state of the economy, and as a result, non-uniformity in values occur may over time within tax jurisdictions whether or not property values increase or decrease; and

WHEREAS, in agreement with the City's Assessor, a longer revaluation cycle, for a growing city like Portland, creates more opportunity for inequities to grow and usually leads to much larger and unpredictable changes to property values, and a shorter cycle will reduce the chances of this happening and help make property taxes more equitable, predictable and manageable; and

WHEREAS, it should be noted, that all City of Portland revaluation notices sent in 2021 will contain information on appeal procedures, and if, after an appeal, a property owner still disagrees with the findings and assessed value of his/her property, they may file a written Application for Abatement with the City of Portland Board of Assessment Review, or look into one of the many tax relief programs available;

NOW, THEREFORE, BE IT RESOLVED, that the Portland City Council and Mayor strongly recommend that the City Tax Assessor and the City Manager, as necessary, conduct ongoing work to support City wide revaluations every five (5) years; and

BE IT FURTHER RESOLVED, that this Portland City Council and Mayor strongly further recommend allocation of sufficient funds to support such city wide revaluations every five (5) years.

Re: FY25 Capital Improvement Plan (CIP) Budget

This is my third year making Capital Improvement Plan (CIP) recommendations to the City Council while performing the role of City Manager. It is always a difficult process due to the sheer volume of immediate capital needs (estimated to be in excess of \$70M for FY25 alone), but I have done my best to consider input from my Department Heads, elected officials, the Library Director and School Superintendent. The City Council goals, in particular the 2023 and 2024 emphasis on equity and sustainability, were considered heavily during my review of submissions. The complete list of recommended projects for FY25 are attached as Appendix A. The following is a summary of those recommendations.

We are faced with the ongoing challenge of meeting as many immediate capital needs as possible without increasing debt service costs for the City related to CIP projects. Each year the City retires older debt related to past CIP borrowings (debt is typically retired 10-20 years after original issuance), and therefore we can issue new debt in its place without increasing overall debt service cost to the City/increasing property taxes related to capital improvement. The “borrowing target” (i.e. the amount of general obligation bonds which can be issued in the upcoming fiscal year without a significant impact to general fund debt service related to capital improvement) plus additional funding sources available in addition to new debt issuance was determined to be approximately \$21M. The current year’s requests were in excess of \$70M¹ when considering all of the needs across the City, Schools, Library, and our Enterprise Funds.

Despite all of the constraints, I am pleased to bring forward a plan that again includes 100% of the projects recommended by the Portland Public Schools Board of Education in my list of CIP projects for FY25. 10 new projects are being recommended via the issuance of \$3.05M in new general obligation bonds. The Superintendent and his facilities staff took on the difficult work of trimming the complete list of PPS capital requests down to an affordable and manageable number of critical projects. The PPS Board recommendations this year have a “safe, warm and dry” theme, three of the most basic needs for any school facility. In addition to the 10 new projects being recommended in my current year CIP, the Schools have approximately \$7M of funding from prior year CIP projects to utilize for capital improvements in FY25 and beyond. I am confident these investments, combined with the soon to be completed \$64M in Buildings for our Future (“BFOF”) projects, will continue to significantly improve our Schools.

¹ Many Departments made reductions prior to submission of their FY25 requestt, pushing projects unlikely to be funded to outer years in the CIP.

Our investments in School facilities are not limited to recommendations from the Superintendent and Board of Education. City Parks and Recreation staff include all recreational facilities in their CIP priorities, including facilities located in/at or used primarily by the School Department. My FY25 CIP recommendations more than double the investment in School facilities by adding an additional \$3.1M in recommended projects. These investments include a badly needed but costly repair at the Riverton pool (\$2.3M) one of the few indoor swimming facilities in the City available to all. My recommendations also include funding to correct a Title IX equity issue via construction of new facilities at Payson Park (\$300k.) Finally, my recommendations include funding to complete construction of a brand new playground at Reiche School (\$500k) which will complement the recently completed BFOF renovation.

My CIP recommendation also includes funding for many much needed projects that impact City buildings and infrastructure. Parks & Recreation recommendations include funding to re-pave the Tukey's bridge approach on the widely used Back Cove pathway, replace a chiller at our public ice arena facility, begin design work on our Stone Street playground replacement in Bayside, add lighting at Payson Park for our tennis / pickleball courts, and add electricity to our Food Truck promenade to reduce emissions and more.

Additionally, my recommendations for the upcoming year include an approximately \$400k investment in the City's Information Technology (IT) infrastructure. Our fantastic IT team continues to save City taxpayers money by managing many of our servers, network and IT infrastructure in-house versus paying a costly annual fee for outsourcing such services. However, as we noted in prior CIP years, we are reaching the end of life for many of our servers and switches and must protect the integrity of our systems and servers.

The list of CIP projects recommended for FY25 also includes continued significant investment at the Portland Public Library. In addition to the \$500,000 recommended in FY24, \$250,000 of which is still available for use in the current year, I am recommending an additional \$675,000 to continue repairs and replacement of their air handling units, the roof, and complete a facilities study for all Library locations.

My CIP recommendation further includes a final \$750,000 investment in the Congress Square Park project as proposed by the Friends of Congress Square Park via the City's Planning & Urban Development Department. This figure is intended to be the City's final investment in the project and has been presented as the last needed amount to complete the park portion of the project. We appreciate the Friends ongoing fundraising efforts and understand any future needs for the project will be funded privately if necessary. It is also worth noting that my recommendations also include required funding for the Congress Square intersection redesign.

Although not technically a CIP item, an area of focus for the City over the last several years has been equity in tax assessment. In fact, in 2021 the Council unanimously approved a resolution to recommend revaluations to be performed at least every 5 years. Staff agrees that this item requires attention to prevent inequity in assessments and to remain in compliance with State

rules. In order to complete a revaluation for tax year FY26 work must begin on this effort this spring. Therefore, I am recommending a funding appropriation occur alongside this year's CIP funding appropriation to move the revaluation effort forward. I've included an accompanying memo from our Tax Assessor Elisa A. Marr that describes the need and request in more detail.

Other items of note within my CIP recommendations include, but are not limited to:

- A significant investment in the required replacement of our Fire Department's self-contained breathing apparatus ("SCBA") equipment. This is the first year of a two year replacement cycle;
- Various additional investments at our fire stations including funding to complete the restroom renovation project (which creates three single use restrooms from the existing large men's restroom), funding for protective equipment for first responders, funding for water piping and Bramhall, and repair work at various stations;
- Various improvements at The Barron Center including funding to correct a restroom equity issue at the laundry facility and funding to fix walkway and parking lot lighting;
- A significant investment in our vehicle fleet, including:
 - Replacement of a Social Services vehicle used to transport our most vulnerable population;
 - Significant funding for electric and hybrid vehicles and equipment;
 - Funding for replacement solid waste equipment; and
 - Funding for various winter operations, public works and parks & rec equipment;
- Funding for minor repairs at the Spring Street and Temple Street garages;
- Significant investments in City sidewalk and ADA compliance improvements;
- Funding for mold remediation and future leak prevention at Hadlock Field;
- Funding for additional traffic signal improvements;
- Funding for additional bike safety transportation improvements;
- Continued funding for the Islands Improvement Program in order to allow the Department of Public Works to complete various smaller public works related capital projects across our city islands during the fiscal year; and
- Continued funding for waterfront infrastructure improvements.

I look forward to discussing all of my recommended projects and funding sources in more detail at the Thursday, February 8th Finance Committee meeting. I will be joined by a group of City staff including various Department Heads who will assist with the presentation.

New businesses will be identified and added to the tax roll and out of business accounts will be verified and removed from the tax rolls. Existing business account listings will be reviewed. This project will result in an inventory of all the business equipment in the City.

Project Justification

Identifying new accounts and accounts that are not reporting or are under reporting will create fairness and equity in personal property assessing. While this project has the potential to generate considerable new revenue for the City, it is more important to create a fair and equitable personal property listing. Many businesses either do not report at all or significantly under report. The City has not had an independent review/revaluation of its personal property base in at least 30 years. There is no record of it ever being done.

NOTE: On October of 2023 Assessing Offices in Maine received correspondence from Jerome Gerard, the State Tax Assessor regarding "Reminder of Compliance with Maine Tax Laws". In this letter the State Tax Assessor states that the "Maine Constitution and Title 36 of the Maine Revised Statutes require that taxes on real and personal property be apportioned and assessed equally according to the just value thereof." Assessor Gerard further states that failure to comply with the requirement to assess personal property could directly impact the accuracy of the state valuation and MRS's certification thereof to the Secretary of State. He further requests Assessors to please review your municipality's assessment practices to ensure that all personal property is being properly assessed...

Although the City of Portland has historically assessed personal property, I believe the City may not be meeting the requirement of equal assessment regarding personal property.

To meet State property tax guidelines, reestablish equitable assessments and to comply with the Council Resuolution, the Assesising Office would need to start the revaluation process in 2024. Project Description

475' linear feet of sloped pathway down from Tukey's bridge to back cove trail system needs to be changed from stone dust pathway condition to asphalt path. Existing fence on either side of the pathway is aged and exhibiting paint peeling and material degradation from exposure to elements. Fencing is important for this project as the pathway directly abuts an active edge of I-295 on the south side of the trail edge, and steep embankment conditions directly down from trail shoulder into Back Cove mudflats and tidal waters. Work will most likely entail mobilization of equipment, removal of surface and some excavation of gully/ wash out areas. If the subbase (base stone of trail) is compromised, entire excavation and rebuilding of the base will be necessary. Possibly some shoulder / embankment stabilization could be possible, but unlikely for any fence repair or replacement. At least 3" thick asphalt surface course would be required to replace failing stone dust.

Project Justification

A significant sloped portion of the multi-use trail from Tukey's bridge walkway down to the back cove trail has been made of stone dust that exhibits signs of gulying and erosion. This is a significant maintenance and safety concern for staff and public users of the trail, particularly as erosion and gulying is occurring in the centerline of the trail and is hard to avoid for any trail user. This trail sees significant pedestrian and cyclist use, and connects the peninsula to off peninsula neighborhoods, providing one of the few traffic separated crossing connections for pedestrians and cyclists in the city. This is a critical pathway of infrastructure that would benefit from a more appropriate and longer lasting path surfacing approach.

Fencing is a critical component of this effort, to both prevent inappropriate uses of shoulder and embankment conditions occurring (encampments or dangerous circulation routes). It also is necessary to keep any mishaps that may happen unexpectedly for trail users from becoming more dangerous by accidental careening over embankment edges or into interstate traffic.

By replacing a more erodible material being used in steep slope circumstances with a more durable asphalt base, the trail , if built appropriately, should have increased durability, lower maintenance costs, and be easier to maintain in winter or rainy conditions.

Reiche Playground Replacement

In spring 2023, PRF secured CIP funds for design/engineering consulting services for the Reiche playground. On the same timeline, the Reiche School PTO sponsored two design charrettes and an enrichment course focused on creatively re-envisioning the Reiche Playground as a more accessible, sustainable and engaging space for learning, playing and socializing. Over the course of summer and fall of 2023, PRF conducted two community surveys and one PPS and Recreation staff survey. These surveys were translated into five languages and received over 130 responses. The survey responses helped to identify challenges with the existing playground and prioritized areas for improvement. The surveys also allowed community members and school staff to review concept design alternatives and express preferences and priorities that ultimately shaped the preferred concept design (Option D) attached to this funding request. Over the course of winter and spring of 2024, the design consultants will further refine the design, generate construction documents and support permitting and site plan review.

The proposed scope of work involves replacing and expanding the existing playground to include both conventional play equipment and natural play environments that offer a wider range of play opportunities for children aged 2-12 as well as two bucket swings and a sand area appropriate for infants.

The proposed playground would support both highly active/physical play as well as solitary/imaginative play. The design works to preserve existing healthy trees, limiting tree removal to trees that are unhealthy and pose a risk to playground users. Site work would include redesigned pathway connections to improve ADA accessibility into and within the playground, adding internal path loops for children learning to use scooters and bikes. Notably, site improvements will also address the existing playground's significant erosion issues by reconfiguring play equipment onto flatter portions of the site and limiting slopes to planted areas. The proposed site improvements include planting a diverse array of native shrubs and trees that will result in increased shade in future years and add to the site's resilience to pests and disease.

To keep the proposed playground as cost effective as possible, the proposed improvements will maintain and protect the majority of the existing asphalt pavement that serves as the school's gathering space during fire drills and is a popular place for kids to play four square and learn to ride bikes. The design also reuses the wood from removed trees and repurposes existing boulders on site

Project Justification

Located in Portland's West End neighborhood, adjacent to Reiche Elementary School and Community Center, the Reiche Playground is one of Portland's most heavily used public playgrounds. During the school year, it serves approximately 445 students ranging from pre-K to 5th grade. The Reiche student body is incredibly diverse, representing 21 birth countries and 18 different home languages. Fifty percent of the school population are multilingual learners. Eighty-three percent of the school's students qualify for the Free and Reduced Lunch program. Eighteen percent of the students live in temporary situations and are unhoused.

The Reiche Playground serves as a safe public place for children to gather, learn, play and exercise. It also serves as an outdoor classroom for children, whether through school, daycare, or aftercare programs. Especially in the summer, the playground serves as a community gathering space for potlucks and neighborhood events.

The existing playground is approximately 20 years old and the play equipment has been repaired, replaced and, in some cases, removed due to safety concerns as it deteriorates. The playground is currently concentrated on a sloping site without adequate slope retention, resulting in ongoing erosion as well as ADA accessibility issues. As play surfacing erodes down the slope, the playground is left with inadequate safety surfacing and cross-slopes that render it inaccessible. Over time, erosion and compaction have exposed tree roots and are compromising long-term tree health around the perimeter of the schoolyard. The existing play equipment offers few options for children with mobility challenges to play alongside their classmates. The playground overall features very few areas for outdoor classes to gather and limited shady places to sit. Additionally, the existing school yard does not serve older children as they tend to prefer highly active play (such as soccer) or more stationary social engagement that would be supported by gathering spaces and seating. Given the highly urbanized neighborhood context around Reiche School, students currently have a very limited amount of open space to

utilize during recess compared to other Portland schools which have more open space at their disposal. The proposed design allows the Reiche Schoolyard to be much more intensively used by a wider range of ages and abilities- providing enough space and play equipment to meet the school and community needs.

The consultant will engage with the community to create a new design for this playground while preserving as much of the mature canopy as possible. The consultant will then propose to the City the play structure and site work costs so that Parks Staff can build that number into a future years CIP request. Additionally, the consultant will help with the bidding process, permitting and construction administration.

Project Justification

The Stone Street Playground is the next highest priority playground in need of replacement determined by the Cities 3 Certified Playground Safety Inspectors. This playground was built back in 2002 and resides in the dense Bayside Neighborhood. Neighborhood playgrounds are built to last roughly 15-20 years with average use. This particular space is the only playground within a ¼ mile to the North, a ⅓ of a mile to the East, ⅔ of a mile to the West and ½ mile to the South which puts a significant amount of pressure on the space.

There are currently multiple play elements that have been removed and/or blocked off for access due to safety concerns to the public. You will notice a board has been attached in the imagery of where a slide was removed. The West side of the playground is retained by a prefabricated stone wall along Oxford Street of which more than a foot currently resides within the Right Of Way (ROW). Part of this reconstruction will be to move that wall within the boundary of the parcel and allow for accessibility along the perimeter sidewalk. The fencing surrounding the park is in need of significant repair or replacement due to its age and abuse over the last 20 years. The gates are also not as functional as they could be. The water feature within the playground is a highly sought after element during the hot Summer months by the community. This unit is regularly seeing repairs from our crew due to its style and age.

Private fundraising on the part of the Friends of Congress Sqaure is providing \$900,000 for Phase B construction. This project received a FY23 CIP allocation in the amount of \$900,000 and a \$700,000 FY24 allocation, splitting the project funding over three years. This third request is to complete the funding needed for construction. The request includes an additional \$50,000 over prior year budgets to reflect a rise in costs over the past several years since the initial cost estimates. A portion of the total \$3,250,000 needed for construction, with the understanding the total request would be made across two years. Previous years included Planning/Design funding, including additional contributions from Friends of Congress Square. Not included in the totals is money for a major public art installation in the square, be funded through a combination of private fundraising, National Endowment for the Arts funding, and Portland Public Art funding for an additonal \$1,400,000 of investment in the square that is not represented in the CIP request. 2024 "other funding" field represents a combination of public art and construction funding that is misleading in the totals above, but the 2022 and 2024 other funding fields represent total FOCS contributions to construction documents and construction, minus the public art work. This project is also impact fee eligible, which could potentially offset the total CIP request.

Operating Budget Impact

The changes in the intersection are anticipated to have an operating budget neutral impact. There will be changes to the roadway configuration that will result in less pavement to plow/maintain. The plaza spaces are designed to require as minimal maintenance as possible with the suggestion that the City continue to enter into a MOU with Friends of Congress Square Park for programming and some maintenance.

Mold was found in the exterior wall in the ticket office located on the 1st floor. Ongoing testing and cleaning is being done. There is evidence of water damage in the entire wall assembly, thus leading to rot and mold. The long-term solution is to rebuild the brick wall completely, approximately 2,150 sqaure feet. The Cummings Center/Munjoy Fire Station does not have a sprinkler system. There is an existing 4-Inch water service located in the boiler room of Munjoy Fire Station that serves the Observatory’s (neighboring building) sprinkler system. In 2019, Fisher Engineering reviewed the existing water supply data and configuration. They concluded that the existing 4-Inch water service was adequate to serve the Munjoy Fire Station/Cummings Center building as well.

In August 2022, FEMA awarded the City of Portland a \$100,000 grant to install a sprinkler system at 134 Congress Street. The FEMA grant deadline is August 28, 2024, but the City of Portland can request an extension. FEMA requires the installation of a complete building sprinkler system. In order to do this work, it will require the removal of certain ceilings in order to clean the space up for a sprinkler system. It makes sense to install a ventilation system while the ceilings are removed.

Additionally, the existing conventional Fire Alarm system should be upgraded with the installation of a new sprinkler system. The quantity of fire alarm devices can be reduced and the new fire alarm panel will be addressable.

The areas of heavy spalling and rebar corrosion on the bottom of the slabs, between Stations 0+40 and 0+50, fall directly beneath the driveway into the warehouse structure. Bents 1 and 3 both have failed caps at the same location. These defects, combined with the loss of compressive strength on the top side of the concrete deck, lead us to recommend that the areas directly beneath the driveway be replaced with new concrete decking and timber caps as soon as is practicable, and that access to the remainder of the concrete deck be cordoned off and restricted.

Spans are almost entirely at ten-foot centers, and the solution utilized in 2008 has proven effective. A similar repair, with the additional replacement of timber caps, should prove cost effective and relatively easy to install. TEC Associates would be happy to work with the City on next steps should you wish.

Greeting Brendan and Tiffany,

Portland Public Library would like to submit for consideration the following CIP projects for FY25.

As you are aware, the 5 Monument Sq location has several failing building systems that affect the overall integrity of the building and the safety of our staff and patrons. In FY23 we saw the failure of the roof top chiller that was installed in 1999 and required an emergency replacement.

The air handlers are near or at the end of their useful life and are costing thousands in repair just to keep them cobbled together and running. There are roof failures, paving needs, dehumidification, and ventilation needs at various locations.

We are also very cognizant of the limitations of the City to provide funding to many buildings that the City serves. Below are the CIP requests that we feel are most pressing to the integrity and safety of the library buildings.

Replace Air Handlers 1 and 3 - 5 Monument Square

In consultation with our vendor Trane, it has been determined that the air handlers that should be replaced as soon as possible are air handlers 1 and 3. The estimated cost to replace this equipment is **\$450,000.**

Replace roof 11, 4, 5 – 5 Monument Square

In FY24 there was a request to replace roof 11, 4 and 5. An estimate of the repairs has been sent and is included in this transmission as well. The rain and snow melt infiltration into the building is not merely an issue of the roof failing but also cause for alarm for the health and safety of staff and patrons. As we saw with the mold situation at the Talbot School (Riverton Branch) this year the cost to remediate the occurrence of mold is costly and can be avoided by repairing the areas of the roof that are causing the water infiltration. The estimated cost to repair/replace is **\$315,000.**

In FY21 there was a request for the replacement of the Portland Room fire protection. I am under the understanding that his project was approved for funding but has yet to be completed. I am not certain as to how to go about accessing these funds from FY21. Below is the original justification for the ask. The current market cost to replace is **\$125,000.**

Replace Portland Room Fire Protection

The Portland Room, with its special collections, is protected by a Halon system that was installed when the building was constructed in the late 1970's. In the ensuing 40-plus years, halon has been discontinued as a viable fire suppression tool because of its effect on the ozone layer. Moreover, the equipment itself is old and there is a risk of failure. If the current system were to discharge, it cannot be refilled as halon has been outlawed. In addition, there is a separate, adjacent archive space that has no fire protection that an updated system should be extended into.

Dehumidification and ventilation upgrades – Riverton Branch (Talbot School)

In FY24 the Riverton Branch, along with the Talbot School, had the need to remediate mold due to moisture in the space. The cost to the library for this unanticipated expense was \$22,100. To avoid this situation in the future, and for the safety of staff and patrons, we must address the high moisture content in the space. This would be a two-part process; first upgrade the ventilation system that serves the library space, second, install a commercial wall mounted dehumidifier that accommodates the square footage of the library. These projects would be done and tandem and are estimated at **\$30,000**.

Pavement of the loading dock parking lot at 5 Monument Square and Parking Lot at 277 Stevens Avenue

This request was made with the FY23 CIP and is being included with the FY25 request for approval. Both parking lot areas are in disarray with multiple cracks and crumbling pavement. There are safety and liability concerns for staff and patrons that access these areas. Pictures were provided with the FY23 request and can be supplied again if necessary. Estimated cost to repair \$30,000

ADA considerations at 5 Monument Square

The library has been looking at signage regarding accessibility and ADA compliance. The current signage has been assessed and a plan to update building's public floors has been completed. In addition, the leaking caused by a faulty air handler in early 2023 caused damage to existing carpet in the children's area that resulted in water-damaged and uneven carpet. Estimated cost to be \$25,000.

Facilities Study for all locations

As stated previously, many of the library's buildings are in disrepair and are relying on equipment that is likely far past their expected lifespan. With so many needs it can be difficult to prioritize and plan for the future repair of the building without more information. A facilities study of all library locations will help us to prioritize and plan for future needs in the most efficient and effective way possible. Estimated cost to be \$30,000

In summary, the library buildings need several life safety upgrades. We have only provided the most pressing needs at this time.

Lincoln Middle School Proposed Project

Replace heating system (Warm)

\$800,000

Rationale:

- Identified through 2016 Assessment as near the end of its service life

This is a municipal match for MPI Paving Projects. A percentage of the project is paid by PACTS or MaineDOT and the City matches the rest. Canco Road is the project planned for this year but this funding may be used for other MPI Projects in the future. The current match is \$250,000 provided by PACTS and is approximately 26% of the estimated project costs. Work on these projects typically includes milling, paving, ADA upgrades to ramps within the project limits, sidewalk repair to areas that are in need, and some curb reset or replacement. Some minor stormwater improvements will be included (requested separately) as well as striping. 10% contingency is included in this request.

Project Justification

The roads typically chosen for this program have low PCI's and are either Collectors or Arterials. Canco Road was evaluated in 2022 and reported to have a PCI of 54 which is considered Poor; this is quite low for a heavily travelled Collector road. In addition, improvements to the sidewalk and ramps here will improve pedestrian access for a heavily trafficked pedestrian area. As part of the MPI program, a portion of project costs will be paid for by the MPO which is a good way to leverage City funds.

Funds are needed to maintain positive flow and safe access for driveways, adjustment of curb including work to comply with ADA, replacement/revisions to pavement markings and traffic signals (see separate Traffic signals request), adjustment/repair to sanitary/storm structures (see Sewer Fund requests).

Project Justification

Our 2022 street inventory concluded that 63% of the road segments in Portland are ranked Fair or lower requiring treatments such as overlays and mill and fills. Only 10% of the streets were deemed to be in good enough condition to only require deferred maintenance. The work to repair these streets are part of our Pavement Preservation Program equating to approximately 250 lane miles of roads. It is clear from this information, as well as the continual complaints and pothole repair requests that many streets in the City are in disrepair. The cost to maintain a road in poor condition will be four to six times higher than a road that is in good or better condition. We need to maintain the roads that are in good condition while providing upgrades to those in poor condition. Maintaining an adequate roadway system is essential to support transportation including vehicular, transit, pedestrian, and bicycle traffic throughout the city.

Keeping more streets in a good condition greatly reduces the annual maintenance costs city wide and also reduces hours needed to address concerns from residents/business regarding poor street condition.

In-house staff may be asked to help with small scale repairs that are not a good fit or are too small for a larger contract. New sidewalk segments may be added to winter sidewalk plow routes and increase operating costs. Rehabilitation of sidewalks and ramps in poor condition will reduce operating costs related to temporary repairs, and may reduce liability claims.

This portion of Forest Avenue had a series of preliminary recommendations set forth in the PACTS Smart Corridor Study, completed in 2017.

As part of this and other previous studies, numerous issues have been identified in this segment of Forest Avenue.

Forest Avenue from Marginal Way to Park Avenue functions as a de-facto barrier between Bayside and Parkside. It is four to six lanes in width, with no access or crossings for pedestrians anywhere except along its ends. Access is limited at Kennebec Street, which is currently one-way only, and High Street's route through Deering Oaks cuts off the historic Rose Garden from the Forest Avenue frontage.

The Smart Corridor Study, completed in 2019, provided recommendations to resolve many of these issues, including realignment of Kennebec Street, shifting High Street's access point with Forest Avenue to the south to improve intersection spacing, and adjustments to the Forest Avenue/Park Avenue intersection to right-size its curb to curb footprint relative to its traffic volume and pedestrian volume and make it a more compact urban intersection. The Bayside Trail would be extended through Forest Avenue at the realigned Kennebec Street, providing access to Deering Oaks and points south and west.

The benefits of the project include:

Improve intersection/traffic signal efficiency via better spacing of signals by relocating High Street

Increase pedestrian access along and across Forest Avenue at its intersections by reducing crossing distances, making intersections ADA-compliant and eliminating the slip lane at Park Avenue

This project was submitted for preliminary design to PACTS in 2021 and is now funded for PDR.

The FY16 funding request is for component and communications upgrades for the intersections of Congress/India, Congress/Washington, and Washington/Cumberland. The equipment is generally out of date, and in some cases, begun to malfunction. The total request is for \$271,770 in equipment upgrades, plus the PACTS match of \$5,500, for \$277,270. The existing FY15 funds will be allotted between the local match for the Congress Street work (\$82,500), with the remainder going to Washington Avenue and Auburn Street improvements.

Project Justification

The City of Portland has partnered with Portland Area Comprehensive Transportation Study (PACTS), as well as the Cities of Westbrook, South Portland, Biddford, Saco and the Town of Scarborough to oversee the deployment of transportation management systems for the more efficient flow of traffic and improved detection for all modes along the City's major travel corridors. Work to date has included upgrades along Riverside Street, Brighton Avenue and Forest Avenue.

Project Justification

Properly updated and coordinated signal systems, along with state-of-the-art detection and pedestrian/bicycle crossing devices, can improve traffic flow along major corridors and provide safety for all modes of travel. At this time, the City has approximately 122 active signal systems.

Portland invested heavily in its signal systems about 30 years ago, and had a very modern OSAM (DOS-based) control system. The City is now fully two-generations from this system, in its first stages of placing Advanced Traffic Control Systems (ATC), tied to an updated ATMS.now-based state-of-the-art communications system. In addition, the age of much of the equipment has gotten to the point where a number of signal control cabinets have moisture problems, controllers fail, wiring is corroding, and bases are rusting away. Some type of signal failure, ranging from lights going to flash to broken wires to complete power loss happens several times a week, usually due to the age of the equipment.

The traffic technicians have become less about regular maintenance and fine-tuning and more about emergency response, having to act, often on-call after hours, to ensure the safe and efficient passage of movement along Portland's major routes.

Furthermore, current ADA and state/federal requirements dictate having larger and brighter, LED-based lighting, pedestrian crossing buttons with audio, countdown heads with a seconds indicator, video or infrared-based camera detection, 12-inch signal heads with reflective back plates and fiber-optic interconnect to bring signal systems into the 21st century. While the RTMS-based funding from PACTS and in a separate CIP account have allowed for some corridor optimization, many locations simply do not meet current operational requirements, nor do they demonstrate adequate reliability.

This year's request and subsequent requests are part of a five-year plan to bring the City's signal systems to a reliable, modern and compliant state, and allow for better pedestrian provisions, bicycle detection, and flexible timing plans during special events. The request for State Street will begin to address issues of lack of connectivity and aging equipment, and all upgrades will be able to accommodate future changes in traffic patterns if a two-way conversion is to take place at some time in the future.

Signal equipment requests in this CIP line item as of 2018 will be for signal-specific projects.

10/17/17: Railroad Quiet Zones (RRQZ) are designated railroad locations or corridors that restrict trains from using their train horns as warnings as the train enters the RRQZ.

Pan Am Railroad Company operates in three (3) Portland RRQZs over a total of twenty (20) public highway/railroad at grade crossings in the City. Many of our crossings are very close to residential areas such as in the Deering Highlands area, Woodfords' Corner and some North Deering neighborhoods as well. While certainly not wanting to compromise safety, the ability to restrict the rail carrier from automatic horn or whistle activation allows these neighborhoods and districts to maintain quality of living elements while reducing excessive noise. The three (3) Quiet Zones in the City of Portland are as defined as follows:

RRQZ 1-Portland Mountain Division II. The crossings in the Portland Mountain Division II Quiet Zone are: Congress Street; Frost Street; Rand Road; and Pine Tree Industrial Parkway.

RRQZ 2- Portland WN & P II. The crossings in the Portland WN&P Quiet Zone are: Forest Avenue and Bishop Street.

RRQZ 3- Portland ST. Maine Line II. The crossings in the Portland St Maine Line II are: Congress Street; Brighton Avenue; Prospect Street; Ashmont Street; Coyle Street; Lincoln Street; Revere Street; Woodfords Street; Saunders Street; Forest Avenue; Walton Street; Read Street; Allen Avenue; Riverside Street.

The Federal Rail Authority (FRA) requires that RRQZ be in compliance with safety guidelines and if not the municipality must implement Supplemental Safety Measurements (SSM) to maintain the RRQZ. Since funding for SSM's is not available through any State or Federal agency and there are no grant funds available, staff believes that it is prudent to budget \$800,000 a year for each of the next five years in the City's CIP. Recent conversations with Pan Am have indicated that they may agree to a four-gate equipment upgrade system, which provides a significant reduction in risk without the property impacts associated with a median treatment or the higher costs associated with full quad gates. Current funding should allow for completion of work at Brighton Avenue and Walton Street. This request would be for a four-gate system to be provided at the Allen Avenue crossing.

\$800,000 funded in FY 2017.

Project Justification

Pan Am Railroad lines and crossings were upgraded to accommodate the 2012 extension of the Downeaster passenger train service between Portland and Brunswick with two (5) round trips per day going through the Portland corridor. For comparisons, presently there can be as many as eight (8) freight trains that travel through this Portland corridor daily now there will be at least 14 trips through the corridor. The train speed of the Downeaster within the City limits will be 30 mph from Congress Street to Allen Avenue and outside of the City limits, from Allen Avenue to past Falmouth Road will be 60 mph. Each of the crossings will be equipped with standard equipment including video monitoring, grade crossing predictors, crossing monitor and recording technology, gates, electronic bells, 12 inch flashing lights as well as the ability to record positive gate down status. The FRA does regular inspections and evaluations for rail safety in RRQZ the threshold for requiring improvements in the RRQZ are different than where train horns are allowed. Portland RRQZ still meets FRA requirements but any incident on the system could be problematic so improvements need to be implemented.

The Federal Rail Administration (FRA) is responsible for enforcement of the Quiet Zone designation in cities and towns, and conducts regular compliance evaluations of a community's quiet zone status to assess if that Quiet Zone needs to be modified, continue as is or be removed. These inspections, known as Risk Reviews, evaluate relevant train transportation

and accident data within 5 years preceding the annual risk review. Additionally, the State and the City are responsible for inventory updates that reflect any changes to the crossings, including items such as traffic counts, train frequency and speeds and any local accident data that may not have been reported to the FRA. The FRA attaches a risk assessment number to each crossing that reflects their survey and that supplied by the state and municipality. This risk number is then compared to the National Risk Assessment index. If a quiet zone measurement is higher than the national risk assessment, then the entire Quiet Zone is out of compliance and the Municipality must install Supplemental Safety Measurements (SSM's) to maintain the zone.

There are 14 types of SSM's available for mitigation, but many offer a small risk reduction decrease for a large investment. Others may not be used a certain locations. Because our Quiet Zone with the most crossings – The Maine Line II, goes right through concentrated business and residential areas, we are further confined to a few choices.

The City expects to submit a new inventory and affirmations to the FRA at the end of this year. We expect that increased vehicle and train counts as well as increased speeds will increase our overall risk index. This comes at a time when the National Risk Index is expected to drop, making compliance even more difficult.

As such, the request is to bring the City's signal communications system where adaptive equipment is being installed up to modern communications and reliability standards.

This study would involve hiring a consultant and also installing numerous flow meters within the system for the first year. This project has been added to the Inflow and Infiltration and the initial investigation has been completed. Work is ongoing to design and address connected roof leaders. Additionally, the interceptor in the City owned wetland north of Warren Avenue will likely need rehabilitation.

Project Justification

The completion of Tier 2 separation projects within the Capisic Brook Watershed was supposed to close CSO#42. This action was not successful and more work needs to be done in order to obtain complete closure. The CSO Long Term Control Plan Tier 3 update did not propose any new projects or studies of Capisic Brook because it was thought that at the completion of Tier 2 CSO #42 would be closed. Since this CSO is still overflowing on rain events and we did not meet the goal of Tier 2 a new CIP request has been made in order to correct this and meet our long term control plan and consent decree. By still overflowing at CSO #42 we are not in compliance with our consent decree and DEP may take action due to this.

Additional \$600,000 is needed to complete the Warren Ave - Hicks to Hemmingway project and another 150,000 to remove Warren Ave Roofs

Many businesses either do not report at all or significantly under report. The City has not had an independent review/revaluation of its personal property base in at least 30 years. There is no record of it ever being done.

NOTE: On October of 2023 Assessing Offices in Maine received correspondence from Jerome Gerard, the State Tax Assessor regarding "Reminder of Compliance with Maine Tax Laws". In this letter the State Tax Assessor states that the "Maine Constitution and Title 36 of the Maine Revised Statutes require that taxes on real and personal property be apportioned and assessed equally according to the just value thereof." Assessor Gerard further states that failure to comply with the requirement to assess personal property could directly impact the accuracy of the state valuation and MRS's certification thereof to the Secretary of State. He further requests Assessors to please review your municipality's assessment practices to ensure that all personal property is being properly assessed...

Although the City of Portland has historically assessed personal property, I believe the City may not be meeting the requirement of equal assessment regarding personal property.

The most recent sales ratio study indicates a market value to assessed valuation ratio of 68% (certified ratio of 74%) for sales from July 1, 2023 to December 2023 . State property tax law guidelines require municipalities to be between 70% and 100% of market value. To meet State property tax guidelines, reestablish equitable assessments and to comply with the Council Resuolution, the Assesising Office would need to start the revaluation process in 2024. The anticipated completion date would be the summer of 2025 for FY26.

In FY24, a Central Fire Station Bathroom Renovation CIP Project was approved for \$100,000. Central Fire Station's kitchen is in desperate need of renovation. The commercial range does not have a code compliant Type I hood. The counters and cabinets are falling apart and beyond their useful life, and the space is small and tight. Architectural drawings and specifications for a new kitchen and bathrooms are complete. The kitchen and bathroom share a wall, which would be reconfigured in the renovation and should be done as one project. This project would provide the station with a code compliant kitchen hood (suppression, exhaust, and fire alarm notification), a functional kitchen, individual bathrooms, and a utility room. This request is to reallocate \$110,000 from the unspent FY21 CIP account to this Bathroom and Kitchen Renovation Project. The overall cost estimate of the Central Station project is approximately \$210,000.

In FY21, a Bramhall Fire Station Washroom CIP project was approved for \$150,000. In 2021, the Fire Department received a FEMA grant for new personal protective gear washers and dryers. Because of the grant, the funds for the Bramhall Fire Station Washroom CIP project were not spent. This request is to reallocate the existing \$150,000 CIP funds towards the Central Fire Station Kitchen and Munjoy Fire Station Kitchen.

The Deering Oaks pond walls are in need of reconstruction and repair. PRF proposes that the work proceed in phases, prioritizing the reconstruction and repointing of the vertical wall in the first phase. The pond's vertical walls consist of two distinct wall types : 685 LF of original stacked stone wall installed in the early 1900s which requires replacement and 770 LF of 1980s-era stone faced cast-in-place concrete wall which requires repair.

The stacked stone wall runs parallel to State Street serving as a retaining wall for the fill upon which the roadway and sidewalk are built. The slope between the stacked stone wall and State Street is very steep (exceeds 2:1) and it appears that soil pressure from the roadway and slope has shifted the top of the wall inward to lean towards the pond. This wall is in poor condition with many stretches where structural stones and capstones have fallen or shifted out of place and a stretch of collapsed wall at the pond's southernmost reach. The poor condition of the wall compromises the slope and roadway behind it. In some stretches, the wall is just 7 feet from the edge of the sidewalk. In their 2017 Condition Assessment, Woodard & Curran recommended replacing the stacked stone wall with a stone-faced reinforced concrete wall matching what was installed in the 1980s. The reinforced concrete design would provide the upslope soil support required along State Street. The proposed wall would be faced with stone salvaged from the original stacked wall, supplementing with new stone only when the existing supply of usable stone is exhausted, matching the color, texture and relief pattern of existing pond walls.

The stone-faced concrete wall was installed in the 1980s and requires regrouting all joints and resetting of detached stones. This work will extend the wall's longevity and restore its appearance. This more minor work should proceed in parallel with the stacked stone wall reconstruction to reduce mobilization and general construction administration costs as the same type of contractor and skillset is required with both wall types.

Project Justification

In 2017, Woodard & Curran performed a condition assessment of the Deering Oaks Pond wall system, identifying sections of wall requiring repair/replacement, recommending repairs, prioritizing them by degree of urgency and generating a cost estimate for the engineering and construction work required. The pond is currently contained by four different wall types: stone-faced reinforced concrete wall dating to the 1980s, stacked stone walls dating to the early 1900s, granite block sloped wall and granite block terraced wall.

The oldest stretch of wall, constructed as grouted stacked-stone, is exhibiting signs of significant deterioration, collapse in some locations, horizontal deflection towards the pond in long stretches and some misaligned capstones. This stretch of wall abuts State Street and requires replacement in order to avoid detrimental effects on the adjacent street, sidewalk and utilities.

The stone-faced reinforced concrete wall constructed in the 1980s has numerous detached facing stones, block stone sliding and failed grout. While this does not affect the structural stability of the wall, it does present a visually unacceptable appearance.

The sloped and terraced granite block walls that surround the rest of the pond appear to be built out of reused roadway curbing, configured in 3-5 steps or rows. Along much of their length, these granite blocks have slid and settled out of place due to the use of unsuitable setting material at their base. The stone blocks that have shifted into the pond result in erosion of pathway material and soil along the pond's edge. The engineer's conditions assessment graded these portions of the wall as lower priority given that they continue to support the majority of the pond edge. PRF proposes to reset the stone blocks on a more structural gravel setting bed in a Phase 2 project.

Having a chain link fence along the water side creates a challenging maintenance obstacle to keep the Japanese knotweed and bittersweet at bay as equipment needs to go up and over the fencing. Chain link is also a difficult barrier for staff to get down the hill to attend to campsites that may have popped up.

This proposal is to replace the aged chain link fence with a galvanized i-beam post and 3"x10" pressure treated timber as the top rail. The conditions of the trail on this ledge make it challenging and cost prohibitive to install wooden posts. Having a lower guardrail along this section of the trail will also provide an easier barrier for staff to maintain the vegetation and toss snow over the edge during the Winter months.

Project Description

In spring 2023, PRF secured CIP funds for design/engineering consulting services for the Reiche playground. On the same timeline, the Reiche School PTO sponsored two design charrettes and an enrichment course focused on creatively re-envisioning the Reiche Playground as a more accessible, sustainable and engaging space for learning, playing and socializing. Over the course of summer and fall of 2023, PRF conducted two community surveys and one PPS and Recreation staff survey. These surveys were translated into five languages and received over 130 responses. The survey responses helped to identify challenges with the existing playground and prioritized areas for improvement. The surveys also allowed community members and school staff to review concept design alternatives and express preferences and priorities that ultimately shaped the preferred concept design (Option D) attached to this funding request. Over the course of winter and spring of 2024, the design consultants will further refine the design, generate construction documents and support permitting and site plan review.

The proposed scope of work involves replacing and expanding the existing playground to include both conventional play equipment and natural play environments that offer a wider range of play opportunities for children aged 2-12 as well as two bucket swings and a sand area appropriate for infants.

The proposed playground would support both highly active/physical play as well as solitary/imaginative play. The design works to preserve existing healthy trees, limiting tree removal to trees that are unhealthy and pose a risk to playground users. Site work would include redesigned pathway connections to improve ADA accessibility into and within the playground, adding internal path loops for children learning to use scooters and bikes. Notably, site improvements will also address the existing playground's significant erosion issues by reconfiguring play equipment onto flatter portions of the site and limiting slopes to planted areas. The proposed site improvements include planting a diverse array of native shrubs and trees that will result in increased shade in future years and add to the site's resilience to pests and disease.

To keep the proposed playground as cost effective as possible, the proposed improvements will maintain and protect the majority of the existing asphalt pavement that serves as the school's gathering space during fire drills and is a popular place for kids to play four square and learn to ride bikes. The design also reuses the wood from removed trees and repurposes existing boulders on site

Project Justification

Located in Portland's West End neighborhood, adjacent to Reiche Elementary School and Community Center, the Reiche Playground is one of Portland's most heavily used public playgrounds. During the school year, it serves approximately 445 students ranging from pre-K to 5th grade. The Reiche student body is incredibly diverse, representing 21 birth countries and 18 different home languages. Fifty percent of the school population are multilingual learners. Eighty-three percent of the school's students qualify for the Free and Reduced Lunch program. Eighteen percent of the students live in temporary situations and are unhoused.

The Reiche Playground serves as a safe public place for children to gather, learn, play and exercise. It also serves as an outdoor classroom for children, whether through school, daycare, or aftercare programs. Especially in the summer, the playground serves as a community gathering space for potlucks and neighborhood events.

The existing playground is approximately 20 years old and the play equipment has been repaired, replaced and, in some cases, removed due to safety concerns as it deteriorates. The playground is currently concentrated on a sloping site without adequate slope retention, resulting in ongoing erosion as well as ADA accessibility issues. As play surfacing erodes down the slope, the playground is left with inadequate safety surfacing and cross-slopes that render it inaccessible. Over time, erosion and compaction have exposed tree roots and are compromising long-term tree health around the perimeter of the schoolyard. The existing play equipment offers few options for children with mobility challenges to play alongside their classmates. The playground overall features very few areas for outdoor classes to gather and limited shady places to sit. Additionally, the existing school yard does not serve older children as they tend to prefer highly active play (such as soccer) or more stationary social engagement that would be supported by gathering spaces and seating. Given the highly urbanized neighborhood context around Reiche School, students currently have a very limited amount of open space to

utilize during recess compared to other Portland schools which have more open space at their disposal. The proposed design allows the Reiche Schoolyard to be much more intensively used by a wider range of ages and abilities- providing enough space and play equipment to meet the school and community needs.

Work will most likely entail mobilization of equipment, removal of surface and some excavation of gully/ wash out areas. If the subbase (base stone of trail) is compromised, entire excavation and rebuilding of the base will be necessary. Possibly some shoulder / embankment stabilization could be possible, but unlikely for any fence repair or replacement. At least 3" thick asphalt surface course would be required to replace failing stone dust.

Project Justification

A significant sloped portion of the multi-use trail from Tukey's bridge walkway down to the back cove trail has been made of stone dust that exhibits signs of gulying and erosion. This is a significant maintenance and safety concern for staff and public users of the trail, particularly as erosion and gulying is occurring in the centerline of the trail and is hard to avoid for any trail user. This trail sees significant pedestrian and cyclist use, and connects the peninsula to off peninsula neighborhoods, providing one of the few traffic separated crossing connections for pedestrians and cyclists in the city. This is a critical pathway of infrastructure that would benefit from a more appropriate and longer lasting path surfacing approach.

Fencing is a critical component of this effort, to both prevent inappropriate uses of shoulder and embankment conditions occurring (encampments or dangerous circulation routes). It also is necessary to keep any mishaps that may happen unexpectedly for trail users from becoming more dangerous by accidental careening over embankment edges or into interstate traffic.

By replacing a more erodible material being used in steep slope circumstances with a more durable asphalt base, the trail , if built appropriately, should have increased durability, lower maintenance costs, and be easier to maintain in winter or rainy conditions.

This funding will support the costs of hiring a consultant to perform the design and engineering work for the reconstruction of the Stone Street Playground in Bayside. The consultant will engage with the community to create a new design for this playground while preserving as much of the mature canopy as possible. The consultant will then propose to the City the play structure and site work costs so that Parks Staff can build that number into a future years CIP request. Additionally, the consultant will help with the bidding process, permitting and construction administration.

Project Justification

The Stone Street Playground is the next highest priority playground in need of replacement determined by the Cities 3 Certified Playground Safety Inspectors. This playground was built back in 2002 and resides in the dense Bayside Neighborhood. Neighborhood playgrounds are built to last roughly 15-20 years with average use. This particular space is the only playground within a ¼ mile to the North, a ⅓ of a mile to the East, ⅓ of a mile to the West and ½ mile to the South which puts a significant amount of pressure on the space.

There are currently multiple play elements that have been removed and/or blocked off for access due to safety concerns to the public. You will notice a board has been attached in the imagery of where a slide was removed. The West side of the playground is retained by a prefabricated stone wall along Oxford Street of which more than a foot currently resides within the Right Of Way (ROW). Part of this reconstruction will be to move that wall within the boundary of the parcel and allow for accessibility along the perimeter sidewalk. The fencing surrounding the park is in need of significant repair or replacement due to its age and abuse over the last 20 years. The gates are also not as functional as they could be. The water feature within the playground is a highly sought after element during the hot Summer months by the community. This unit is regularly seeing repairs from our crew due to its style and age.

After emergency repairs were completed on a tight timeline, a building inspector discovered structural issues with a pool wall and leaking water. The pool was closed indefinitely at that time so repairs could be made. Since that time, staff have contracted with an engineering firm to conduct demolition, testing, and survey work to assess the structural issues and come up with a design and cost estimate for repair. This is a vital recreational facility used by tens of thousands of patrons a year for recreational swimming, swim lessons, school swim team practices, kayak and scuba lessons, senior adult fitness, and even infant swim lessons. Repairing and opening this facility back up to the public is the highest priority for the Parks, Recreation and Facilities Department.

Private fundraising on the part of the Friends of Congress Sqaure is providing \$900,000 for Phase B construction. This project received a FY23 CIP allocation in the amount of \$900,000 and a \$700,000 FY24 allocation, splitting the project funding over three years. This third request is to complete the funding needed for construction. The request includes an additional \$50,000 over prior year budgets to reflect a rise in costs over the past several years since the initial cost estimates. A portion of the total \$3,250,000 needed for construction, with the understanding the total request would be made across two years. Previous years included Planning/Design funding, including additional contributions from Friends of Congress Square. Not included in the totals is money for a major public art installation in the square, be funded through a combination of private fundraising, National Endowment for the Arts funding, and Portland Public Art funding for an additonal \$1,400,000 of investment in the square that is not represented in the CIP request. 2024 "other funding" field represents a combination of public art and construction funding that is misleading in the totals above, but the 2022 and 2024 other funding fields represent total FOCS contributions to construction documents and construction, minus the public art work. This project is also impact fee eligible, which could potentially offset the total CIP request.

The FY2026 funding request of \$250,000 is for local match for construction, anticipating federal and state funding of \$750,000 for construction in 2026.

Project Justification

This pathway fills a key remaining gap to fill in the City's long planned peninsula circumferential pathway network. MaineDOT recognizes the importance of the project, and is funding 100% construction of the Union branch segment and 80% of the design of the Libbytown segment, leaving the 20% matching design funds and ineligible design elements for the City to fund in order to complete these phases of the project.

Spans are almost entirely at ten-foot centers, and the solution utilized in 2008 has proven effective. A similar repair, with the additional replacement of timber caps, should prove cost effective and relatively easy to install. In 2019, Fisher Engineering reviewed the existing water supply data and configuration. They concluded that the existing 4-Inch water service was adequate to serve the Munjoy Fire Station/Cummings Center building as well.

In August 2022, FEMA awarded the City of Portland a \$100,000 grant to install a sprinkler system at 134 Congress Street. The FEMA grant deadline is August 28, 2024, but the City of Portland can request an extension. FEMA requires the installation of a complete building sprinkler system. In order to do this work, it will require the removal of certain ceilings in order to clean the space up for a sprinkler system. It makes sense to install a ventilation system while the ceilings are removed.

Additionally, the existing conventional Fire Alarm system should be upgraded with the installation of a new sprinkler system. The quantity of fire alarm devices can be reduced and the new fire alarm panel will be addressable.

Funds are needed to maintain positive flow and safe access for driveways, adjustment of curb including work to comply with ADA, replacement/revisions to pavement markings and traffic signals (see separate Traffic signals request), adjustment/repair to sanitary/storm structures (see Sewer Fund requests).

Project Justification

Our 2022 street inventory concluded that 63% of the road segments in Portland are ranked Fair or lower requiring treatments such as overlays and mill and fills. Only 10% of the streets were deemed to be in good enough condition to only require deferred maintenance. The work to repair these streets are part of our Pavement Preservation Program equating to approximately 250 lane miles of roads. It is clear from this information, as well as the continual complaints and pothole repair requests that many streets in the City are in disrepair. The cost to maintain a road in poor condition will be four to six times higher than a road that is in good or better condition. We need to maintain the roads that are in good condition while providing upgrades to those in poor condition. Maintaining an adequate roadway system is essential to support transportation including vehicular, transit, pedestrian, and bicycle traffic throughout the city.

Keeping more streets in a good condition greatly reduces the annual maintenance costs city wide and also reduces hours needed to address concerns from residents/business regarding poor street condition.

FY 2025 Request: \$350,000 for complete replacement of equipment at Stevens and Pleasant; \$200,000 for updates on High Street

Project Justification

Properly updated and coordinated signal systems, along with state-of-the-art detection and pedestrian/bicycle crossing devices, can improve traffic flow along major corridors and provide safety for all modes of travel. At this time, the City has approximately 122 active signal systems.

Portland invested heavily in its signal systems about 30 years ago, and had a very modern OSAM (DOS-based) control system. The City is now fully two-generations from this system, in its first stages of placing Advanced Traffic Control Systems (ATC), tied to an updated ATMS.now-based state-of-the-art communications system. In addition, the age of much of the equipment has gotten to the point where a number of signal control cabinets have moisture problems, controllers fail, wiring is corroding, and bases are rusting away. Some type of signal failure, ranging from lights going to flash to broken wires to complete power loss happens several times a week, usually due to the age of the equipment.

The traffic technicians have become less about regular maintenance and fine-tuning and more about emergency response, having to act, often on-call after hours, to ensure the safe and efficient passage of movement along Portland's major routes.

Furthermore, current ADA and state/federal requirements dictate having larger and brighter, LED-based lighting, pedestrian crossing buttons with audio, countdown heads with a seconds indicator, video or infrared-based camera detection, 12-inch signal heads with reflective back plates and fiber-optic interconnect to bring signal systems into the 21st century. While the RTMS-based funding from PACTS and in a separate CIP account have allowed for some corridor optimization, many locations simply do not meet current operational requirements, nor do they demonstrate adequate reliability.

This year's request and subsequent requests are part of a five-year plan to bring the City's signal systems to a reliable, modern and compliant state, and allow for better pedestrian provisions, bicycle detection, and flexible timing plans during special events. The request for State Street will begin to address issues of lack of connectivity and aging equipment, and all upgrades will be able to accommodate future changes in traffic patterns if a two-way conversion is to take place at some time in the future.

Signal equipment requests in this CIP line item as of 2018 will be for signal-specific projects.

10/12/18 Need to hire consultant study the corridor to analyze need for quad crossing versus other solutions.

10/17/17: Railroad Quiet Zones (RRQZ) are designated railroad locations or corridors that restrict trains from using their train horns as warnings as the train enters the RRQZ.

Pan Am Railroad Company operates in three (3) Portland RRQZs over a total of twenty (20) public highway/railroad at grade crossings in the City. Many of our crossings are very close to residential areas such as in the Deering Highlands area, Woodfords' Corner and some North Deering neighborhoods as well. While certainly not wanting to compromise safety, the ability to restrict the rail carrier from automatic horn or whistle activation allows these neighborhoods and districts to maintain quality of living elements while reducing excessive noise. The three (3) Quiet Zones in the City of Portland are as defined as follows:

RRQZ 1-Portland Mountain Division II. The crossings in the Portland Mountain Division II Quiet Zone are: Congress Street; Frost Street; Rand Road; and Pine Tree Industrial Parkway.

RRQZ 2- Portland WN & P II. The crossings in the Portland WN&P Quiet Zone are: Forest Avenue and Bishop Street.

RRQZ 3- Portland ST. Maine Line II. The crossings in the Portland St Maine Line II are: Congress Street; Brighton Avenue; Prospect Street; Ashmont Street; Coyle Street; Lincoln Street; Revere Street; Woodfords Street; Saunders Street; Forest Avenue; Walton Street; Read Street; Allen Avenue; Riverside Street.

The Federal Rail Authority (FRA) requires that RRQZ be in compliance with safety guidelines and if not the municipality must implement Supplemental Safety Measurements (SSM) to maintain the RRQZ. Since funding for SSM's is not available through any State or Federal agency and there are no grant funds available, staff believes that it is prudent to budget \$800,000 a year for each of the next five years in the City's CIP. Recent conversations with Pan Am have indicated that they may agree to a four-gate equipment upgrade system, which provides a significant reduction in risk without the property impacts associated with a median treatment or the higher costs associated with full quad gates. Current funding should allow for completion of work at Brighton Avenue and Walton Street. This request would be for a four-gate system to be provided at the Allen Avenue crossing.

\$800,000 funded in FY 2017.

Project Justification

Pan Am Railroad lines and crossings were upgraded to accommodate the 2012 extension of the Downeaster passenger train service between Portland and Brunswick with two (5) round trips per day going through the Portland corridor. For comparisons, presently there can be as many as eight (8) freight trains that travel through this Portland corridor daily now there will be at least 14 trips through the corridor. The train speed of the Downeaster within the City limits will be 30 mph from Congress Street to Allen Avenue and outside of the City limits, from Allen Avenue to past Falmouth Road will be 60 mph. Each of the crossings will be equipped with standard equipment including video monitoring, grade crossing predictors, crossing monitor and recording technology, gates, electronic bells, 12 inch flashing lights as well as the ability to record positive gate down status. The FRA does regular inspections and evaluations for rail safety in RRQZ the threshold for requiring improvements in the RRQZ are different than where train horns are allowed. Portland RRQZ still meets FRA requirements but any incident on the system could be problematic so improvements need to be implemented.

The Federal Rail Administration (FRA) is responsible for enforcement of the Quiet Zone designation in cities and towns, and conducts regular compliance evaluations of a community's quiet zone status to assess if that Quiet Zone needs to be modified, continue as is or be removed. These inspections, known as Risk Reviews, evaluate relevant train transportation

and accident data within 5 years preceding the annual risk review. Additionally, the State and the City are responsible for inventory updates that reflect any changes to the crossings, including items such as traffic counts, train frequency and speeds and any local accident data that may not have been reported to the FRA. The FRA attaches a risk assessment number to each crossing that reflects their survey and that supplied by the state and municipality. This risk number is then compared to the National Risk Assessment index. If a quiet zone measurement is higher than the national risk assessment, then the entire Quiet Zone is out of compliance and the Municipality must install Supplemental Safety Measurements (SSM's) to maintain the zone.

There are 14 types of SSM's available for mitigation, but many offer a small risk reduction decrease for a large investment. Others may not be used a certain locations. Because our Quiet Zone with the most crossings – The Maine Line II, goes right through concentrated business and residential areas, we are further confined to a few choices.

The City expects to submit a new inventory and affirmations to the FRA at the end of this year. We expect that increased vehicle and train counts as well as increased speeds will increase our overall risk index. This comes at a time when the National Risk Index is expected to drop, making compliance even more difficult.

Local support to augment PACTS UPWP funding for regional transportation system upgrades. Includes money for new equipment and especially improved communications. Anticipate requiring approximately \$200,000 to \$300,000 per year, which includes PACTS funding when a project from PACTS requires a match. In FY18 the City began on a project solely dedicated to updates on Auburn Street and Washington Avenue, solely funded with local money. This request would aid in supplying capital for the communications portion of the work.

The FY16 funding request is for component and communications upgrades for the intersections of Congress/India, Congress/Washington, and Washington/Cumberland. The equipment is generally out of date, and in some cases, begun to malfunction. The total request is for \$271,770 in equipment upgrades, plus the PACTS match of \$5,500, for \$277,270. The existing FY15 funds will be allotted between the local match for the Congress Street work (\$82,500), with the remainder going to Washington Avenue and Auburn Street improvements.

Project Justification

The City of Portland has partnered with Portland Area Comprehensive Transportation Study (PACTS), as well as the Cities of Westbrook, South Portland, Biddford, Saco and the Town of Scarborough to oversee the deployment of transportation management systems for the more efficient flow of traffic and improved detection for all modes along the City's major travel corridors. Work to date has included upgrades along Riverside Street, Brighton Avenue and Forest Avenue.

Significant work remains to be done along several major arterials, as well as in-town corridors. Longer-term, the region anticipates upgrading technology to allow for up-to-date emergency vehicle and transit vehicle pre-emption systems.

The FY2025 Request is for an annual match of PACTS work, so \$25,000.

The Actelis network devices can only be as reliable as the 30+ year copper interconnect that runs throughout the city.

As such, the request is to bring the City's signal communications system where adaptive equipment is being installed up to modern communications and reliability standards.

Access is limited at Kennebec Street, which is currently one-way only, and High Street's route through Deering Oaks cuts off the historic Rose Garden from the Forest Avenue frontage.

The Smart Corridor Study, completed in 2019, provided recommendations to resolve many of these issues, including realignment of Kennebec Street, shifting High Street's access point with Forest Avenue to the south to improve intersection spacing, and adjustments to the Forest Avenue/Park Avenue intersection to right-size its curb to curb footprint relative to its traffic volume and pedestrian volume and make it a more compact urban intersection. The Bayside Trail would be extended through Forest Avenue at the realigned Kennebec Street, providing access to Deering Oaks and points south and west.

The benefits of the project include:

Improve intersection/traffic signal efficiency via better spacing of signals by relocating High Street

Increase pedestrian access along and across Forest Avenue at its intersections by reducing crossing distances, making intersections ADA-compliant and eliminating the slip lane at Park Avenue

This project was submitted for preliminary design to PACTS in 2021 and is now funded for PDR.

Portland's arterials have a long record of challenging crossings of its arterials, in some cases resulting in pedestrian injuries and even deaths. Providing crossings with median islands, flashing beacons, and, in some cases, hybrid beacons have been demonstrated to significantly improve pedestrian safety. Overflows at CSO #42 were supposed to be eliminated at the completion of Tier 2 but they are still occurring even after completing all of the projects outlined in Tier 2 and the CSO Master Plan. This study would involve hiring a consultant and also installing numerous flow meters within the system for the first year. Subsequent years will involve actual design and construction of action items determined by the study to fully close CSO #42.

This project has been added to the Inflow and Infiltration and the initial investigation has been completed. Work is ongoing to design and address connected roof leaders. Additionally, the interceptor in the City owned wetland north of Warren Avenue will likely need rehabilitation.

Project Justification

The completion of Tier 2 separation projects within the Capisic Brook Watershed was supposed to close CSO#42. This action was not successful and more work needs to be done in order to obtain complete closure. The CSO Long Term Control Plan Tier 3 update did not propose any new projects or studies of Capisic Brook because it was thought that at the completion of Tier 2 CSO #42 would be closed. Since this CSO is still overflowing on rain events and we did not meet the goal of Tier 2 a new CIP request has been made in order to correct this and meet our long term control plan and consent decree. By still overflowing at CSO #42 we are not in compliance with our consent decree and DEP may take action due to this.

Additional \$600,000 is needed to complete the Warren Ave - Hicks to Hemmingway project and another 150,000 to remove Warren Ave Roofs

To date, an initial feasibility study was completed for the roadway several years ago, and a second study was completed, with the City Council approving the redesign as a City Transportation Master Plan.

Currently, a preliminary design report product is underway for the portion of Franklin from Oxford to I-295.

The MaineDOT, a partner in the current study process with the City and PACTS, has made it clear that funding for the complete redesign is very unlikely to be totally derived from federal funding. As such, the City will be investigating other funding strategies, including use of local CIP money. While the scope and cost of future design work is still preliminary, it is anticipated that those costs will be significant.

However the Water Resources Division would like to proceed with the installation of the separated storm drain system which will help alleviate flooding in the Somerset Street/Whole Foods area. This project will also help the City continue to mitigate CSO activity in the area.

Another benefit of this project is to reduce stormwater flows that will currently flow into the future Back Cove South Storage Facility tank. Currently a 42" separated storm drain system from Somerset Street and Marginal Way ties downstream of the CSO #18- Franklin Street CSO diversion structure which will direct a significant amount of separated stormwater into the new CSO facility, thus reducing its level of performance. The Franklin Street Street storm drain design is proposing to tie this existing storm drain line into the new storm drain which will discharge into Back Cove through a new separated stormwater outfall near 295-Exit 7. The new outfall box culvert is being installed as part of the Back Cove South Storage Facility project.

The water resources division has completed a preliminary design of a new separated storm drain system throughout the corridor and would like to implement the project in phases.

Phase 1: Marginal Way to Lancaster Street which will include installing a separated drain on Lancaster Street from Franklin Street to Mayo street to capture existing storm drains in Boyd and Mayo street that had been previously separated and reconnected into the combined sewer.

Phase 2: Lancaster Street to Congress Street including providing separation for the top of the Old Port parking lot.

Phase 3: Congress Street to Middle Street.

Franklin Street, rebuilt from a local urban street to a broad, vehicle-dominated thoroughfare in the late 1960's, has long been cited as a major roadway in dire need of redesign. To date, an initial feasibility study was completed for the roadway several years ago, and a second study was completed, with the City Council approving the redesign as a City Transportation Master Plan.

Currently, a preliminary design report product is underway for the portion of Franklin from Oxford to I-295.

The MaineDOT, a partner in the current study process with the City and PACTS, has made it clear that funding for the complete redesign is very unlikely to be totally derived from federal funding. As such, the City will be investigating other funding strategies, including use of local CIP money. While the scope and cost of future design work is still preliminary, it

is anticipated that those costs will be significant.

However the Water Resources Division would like to proceed with the installation of the separated storm drain system which will help alleviate flooding in the Somerset Street/Whole Foods area. This project will also help the City continue to mitigate CSO activity in the area.

Another benefit of this project is to reduce separated stormwater flows that will currently flow into the new Back Cove South Storage Facility tank system. An existing stormwater system in Somerset Street and Marginal Way currently connects to the new CSO tank system, which will fill the a portion of the tank with non-CSO stormwater thus reducing the new storage tanks CSO storage performance level. The Somerset Street flood mitigation Project design is proposing to tie this existing storm drain line into the new storm drain in Franklin Street which will discharge into Back Cove through a new separated stormwater outfall near 295-Exit 7. The new outfall box culvert is being installed as part of the Back Cove South Storage Facility project.

The utility/stormdrain design for the project is at the 95% design level and will be ready for bidding by early winter.

As of the summer of 2021 the transportation division of DPW has decided to reduce the scope of the roadway project and try to complete overall corridor improvements from Marginal Way to Lancaster Street concurrently with the storm drain project. These improvements are under design by Gorriell Palmer. Transportation funding for the roadway/signal improvements will be made as part of a separate general fund CIP request.

Current Project Phasing:

Phase 1: Marginal Way to Cumberland Avenue which will include installing a seperated drain on Lancaster Street from Franklin Street to Mayo street to capture existing storm drains in Boyd and Mayo street that had been previously separated and reconnected into the combined sewer.

Phase 3: Congress Street to Middle Street. (Separate CIP Account to be requested in future years).

Greeting Brendan and Tiffany,

Portland Public Library would like to submit for consideration the following CIP projects for FY25.

As you are aware, the 5 Monument Sq location has several failing building systems that affect the overall integrity of the building and the safety of our staff and patrons. In FY23 we saw the failure of the roof top chiller that was installed in 1999 and required an emergency replacement.

The air handlers are near or at the end of their useful life and are costing thousands in repair just to keep them cobbled together and running. There are roof failures, paving needs, dehumidification, and ventilation needs at various locations.

We are also very cognizant of the limitations of the City to provide funding to many buildings that the City serves. Below are the CIP requests that we feel are most pressing to the integrity and safety of the library buildings.

Replace Air Handlers 1 and 3 - 5 Monument Square

In consultation with our vendor Trane, it has been determined that the air handlers that should be replaced as soon as possible are air handlers 1 and 3. The estimated cost to replace this equipment is **\$450,000.**

Replace roof 11, 4, 5 – 5 Monument Square

In FY24 there was a request to replace roof 11, 4 and 5. An estimate of the repairs has been sent and is included in this transmission as well. The rain and snow melt infiltration into the building is not merely an issue of the roof failing but also cause for alarm for the health and safety of staff and patrons. As we saw with the mold situation at the Talbot School (Riverton Branch) this year the cost to remediate the occurrence of mold is costly and can be avoided by repairing the areas of the roof that are causing the water infiltration. The estimated cost to repair/replace is **\$315,000.**

In FY21 there was a request for the replacement of the Portland Room fire protection. I am under the understanding that his project was approved for funding but has yet to be completed. I am not certain as to how to go about accessing these funds from FY21. Below is the original justification for the ask. The current market cost to replace is **\$125,000.**

Replace Portland Room Fire Protection

The Portland Room, with its special collections, is protected by a Halon system that was installed when the building was constructed in the late 1970's. In the ensuing 40-plus years, halon has been discontinued as a viable fire suppression tool because of its effect on the ozone layer. Moreover, the equipment itself is old and there is a risk of failure. If the current system were to discharge, it cannot be refilled as halon has been outlawed. In addition, there is a separate, adjacent archive space that has no fire protection that an updated system should be extended into.

Dehumidification and ventilation upgrades – Riverton Branch (Talbot School)

In FY24 the Riverton Branch, along with the Talbot School, had the need to remediate mold due to moisture in the space. The cost to the library for this unanticipated expense was \$22,100. To avoid this situation in the future, and for the safety of staff and patrons, we must address the high moisture content in the space. This would be a two-part process; first upgrade the ventilation system that serves the library space, second, install a commercial wall mounted dehumidifier that accommodates the square footage of the library. These projects would be done and tandem and are estimated at **\$30,000**.

Pavement of the loading dock parking lot at 5 Monument Square and Parking Lot at 277 Stevens Avenue

This request was made with the FY23 CIP and is being included with the FY25 request for approval. Both parking lot areas are in disarray with multiple cracks and crumbling pavement. There are safety and liability concerns for staff and patrons that access these areas. Pictures were provided with the FY23 request and can be supplied again if necessary. Estimated cost to repair \$30,000

ADA considerations at 5 Monument Square

The library has been looking at signage regarding accessibility and ADA compliance. The current signage has been assessed and a plan to update building's public floors has been completed. In addition, the leaking caused by a faulty air handler in early 2023 caused damage to existing carpet in the children's area that resulted in water-damaged and uneven carpet. Estimated cost to be \$25,000.

Facilities Study for all locations

As stated previously, many of the library's buildings are in disrepair and are relying on equipment that is likely far past their expected lifespan. With so many needs it can be difficult to prioritize and plan for the future repair of the building without more information. A facilities study of all library locations will help us to prioritize and plan for future needs in the most efficient and effective way possible. Estimated cost to be \$30,000

In summary, the library buildings need several life safety upgrades. We have only provided the most pressing needs at this time.

Lincoln Middle School Proposed Project

Replace heating system (Warm)

\$800,000

Rationale:

- Identified through 2016 Assessment as near the end of its service life
- Replacement was slated for FY23 but was put off due to problems that arose with the boilers at PATHS that had to be prioritized
- Breaks down frequently and requires ongoing repair



Casco Bay HS/PATHS

Repair underground cables (Safe)

\$500,000

Rationale:

- Cable was buried without a conduit and is deteriorating
- As a result, lights in the parking lot do not work, creating a safety hazard



Lyman Moore Middle School

Create secure entrance vestibule (Safe)

\$188,000

Rationale:

- Unlike at other schools, people walking into Moore enter directly into the school lobby rather than entering through a secure vestibule, creating a potential security concern
- Project was identified by the 2016 Assessment as a priority to be completed between 2018 and 2022 but is still outstanding
- As we roll out an updated Comprehensive Emergency Management Plan, it is essential that we address significant gaps such as this



Talbot Community School

Add security cameras (Safe)

\$70,000

Rationale:

- **The school currently has no security cameras to monitor the facilities**
- **As we roll out an updated Comprehensive Emergency Management Plan, it is essential that we address significant gaps such as this**



Deering High School

Replace primary underground electrical cable into building (Safe)

\$285,000

Rationale:

- Identified by 2016 Assessment as a priority between 2023 and 2037, noting that the equipment set-up was “obsolete”
- Electrical issues are high priority from a safety perspective and for ensuring stable functioning of the school



Deering High School

Repair masonry on exterior walls (Dry)

\$500,000

Rationale:

- Water is leaking into the building through exterior walls
- 2016 Assessment identified as a priority due to the walls being near the end of service life



Deering High School

Upgrade server for camera system (Safe)

\$25,000

Rationale:

- The server is at the end of its service life and is essential for supporting the camera systems in four schools (Deering High School, Lincoln Middle School, Longfellow Elementary School, and Rowe Elementary School)



Longfellow Elementary School

Repair exterior walls (Dry)

\$500,000

Rationale:

- Water is leaking in through exterior walls
- Identified by 2016 Assessment as a priority for 2018-2022 due to walls being at the end of their service life
- Recent Buildings For Our Future investment in the school's interior could be jeopardized by exterior leaks



East End Community School

Install security camera system (Safe)

\$70,000

Rationale:

- The school does not currently have a functioning camera system (the old one is obsolete)
- As we roll out an updated Comprehensive Emergency Management Plan, it is essential that we address significant gaps such as this



Multiple Schools

Upgrade door access controls (Safe)

\$115,000

Rationale:

- **High-functioning door access controls are essential for security management**
- **The controls at Deering High School need upgrading and some other schools need detailed improvements**

Capital Improvement Plan (CIP) Definition

What is the Capital Improvements Plan or Program (CIP)? The CIP is a plan that assesses capital facility needs in a jurisdiction against its overall goals and objectives, using a multi-year planning horizon—usually five years. The capital plan contains projects budgeted in the current Fiscal Year as well as projects in subsequent years for which funding may not have been obtained or authorized. Since the CIP is not a legally binding document, it can and does change in the “out” years. The CIP is often spoken of as a rolling document since older projects drop off and new ones are added each year. (Robinson 1991)

Capital Improvement Plan in Portland

What is Required (by City Charter)

- (i) To prepare a five (5) year rolling capital improvement plan for annual presentation to the city council, which plan includes the following:
 - 1. A one (1) year plan of specific projects and their cost;
 - 2. A two (2) through five (5) year plan of specific projects and general categories, and amounts of proposed spending and funding sources; and
 - 3. A discussion of the basis for the plan and the factors which went into its development or amendments.

Capital Improvement Plan in Portland

- Department Requests: Capital project requests are generated directly from within each City Department
 - Total general fund requests are in the \$50M-\$100M range annually, with funding limited to between \$10M-\$20M annually. Enterprise fund projects (Jetport, Water, Sewer, Stormwater) add an additional \$20M - \$70M annually.
 - 5 or 10 year plans developed by Departments and submitted via a CIP database
BEST PRACTICE - Facility capital needs study for specific facility of category of facilities
 - Varying levels of public input gathered by each Department during request process with several public hearings scheduled at School Board, City Council Committee and City Council meetings.

Capital Improvement Plan in Portland

- Projects are scored and ranked by City Manager / Finance based on a number of factors as outlined in our [CIP reports](#).
- Many projects are cut from the current year list / pushed into the outer years of the CIP due to financial constraints / limitations on funding.
- Finance identifies potential alternative funding sources to increase available funds for current year CIP (intersection of the CIP process with capital budgeting / financing capital expenditures process)
- City Manager makes recommendations on current year and five year CIP plan. Finance drafts one year capital budget for approval by City Council

Types of Assets in a Capital Improvement Plan

Capital projects typically fall into to one of the following categories:

- Water / Sewer / Stormwater
- Streets, Streetscapes and Transportation
- Community Facilities
- Equipment and Vehicles
- Energy and Telecommunications
- Housing for Low and Moderate Income Families

Capital Improvement Plan in Portland

In Portland our City Council approves two things related to the CIP based on recommendations from the City Manager and Finance

Capital Improvement Plan: Portland Falling Behind & Catching Up

- In the late 2000's and early 2010's, the City due to financial constraints the City had extremely limited approved Capital Improvement Plan funding.
- Capital assets were falling significantly behind in terms of replacement dates. Operating budget repairs & maintenance expense was rising and the amount of overall deferred maintenance continued to grow at a higher than usual rate.
- In several recent Recommended Capital Improvement Plans, the City Manager recognized the need to catch up in many categories of capital assets City wide and recommended \$5M of catch up funding in addition to the regular CIP.
- This strategy, combined with casting a wide net on available funding sources, has allowed us to make recent progress which needs to be continued.

Capital Improvement Plan: Recent Progress Example - Fleet Vehicles

- Public Works has always maintained an excellent CIP replacement schedule for Fleet Vehicles with purchase dates and scheduled replacement dates.
- Unfortunately, due to fiscal constraints during 2010-2014, in a 630+ vehicle fleet, only approximately 3% per year was upgraded / replaced.
- This triggered a significant backlog of significantly past due fleet vehicles, deferred maintenance, breakdowns, increased vehicle repair and rental costs in the operating budget, and triggered reduction of service levels in some instances when vehicles went out of service unexpectedly.
- From 2015 - 2021 nearly 50% of the fleet was replaced, in excess of 275 vehicles have been replaced, with a significant portion of those purchases being of more energy efficient vehicles.

Capital Improvement Plan: Recent Progress Example - School Department

- From FY10 - FY16 average annual CIP spending on School projects was just over \$1M per year, averaging less than 3 approved projects per CIP year.
- From FY17 - FY21, annual CIP spending on School projects has averaged nearly \$3M per year, with an average of 9+ approved projects per year, including 16 approved projects in the 2021 CIP alone (and these figures exclude buses and the nearly \$30M spent on the Fred P. Hall* School Replacement from 2017/2018 and the Lyseth renovations from 2019/2020).
- PPS project requests will be lower in FY22 and FY23 as their list of approved but yet to be completed projects is longer than usual due to COVID hitting just after CIP approval in late winter 2021.

Capital Improvement Plan - Financing with Bonds (Municipal Borrowing)

Portland City Council has authorized over \$600M of general obligation bonds in the last 10 years alone to fund City, School and Sewer/Stormwater capital projects. Outstanding debt as of **June 30th, 2022** is listed below.

Note 1: Outstanding debt summaries are published annually in the City's award winning [Comprehensive Annual Financial Report](#) and also in the annual Capital Improvement Plan report.

Note 2: The City also has significant authorized but unissued debt (examples include a significant portion of the 2013 CSO authorization, the full FY23 CIP (to be issued in mid 2023), and 1 of the 4 schools included in the \$64M Buildings for our Future elementary schools project.

Capital Improvement Plan - Financing with Bonds (Municipal Borrowing)

- Debt service expense created by City Council municipal borrowing is typically repaid over 10 or 20 years and has a lower initial impact to the property tax levy and sewer/stormwater rates than if projects were paid in cash. The impact in total is larger over the full 10 or 20 year period of debt service repayment due to interest cost but better synchronizes the costs and benefits of infrastructure over time.
- “Borrowing allows a municipality to enjoy the immediate benefit from the capital improvement, which is not always possible when relying on current revenues. Current revenues (taxes and user fees) are usually not sufficient to fund large expenditures on a “pay-as-you-go basis” (PAYGO).....Borrowing allows municipalities to avoid large year-to-year fluctuations in tax rates.” -UN Habitat (Guide to Municipal Finance)

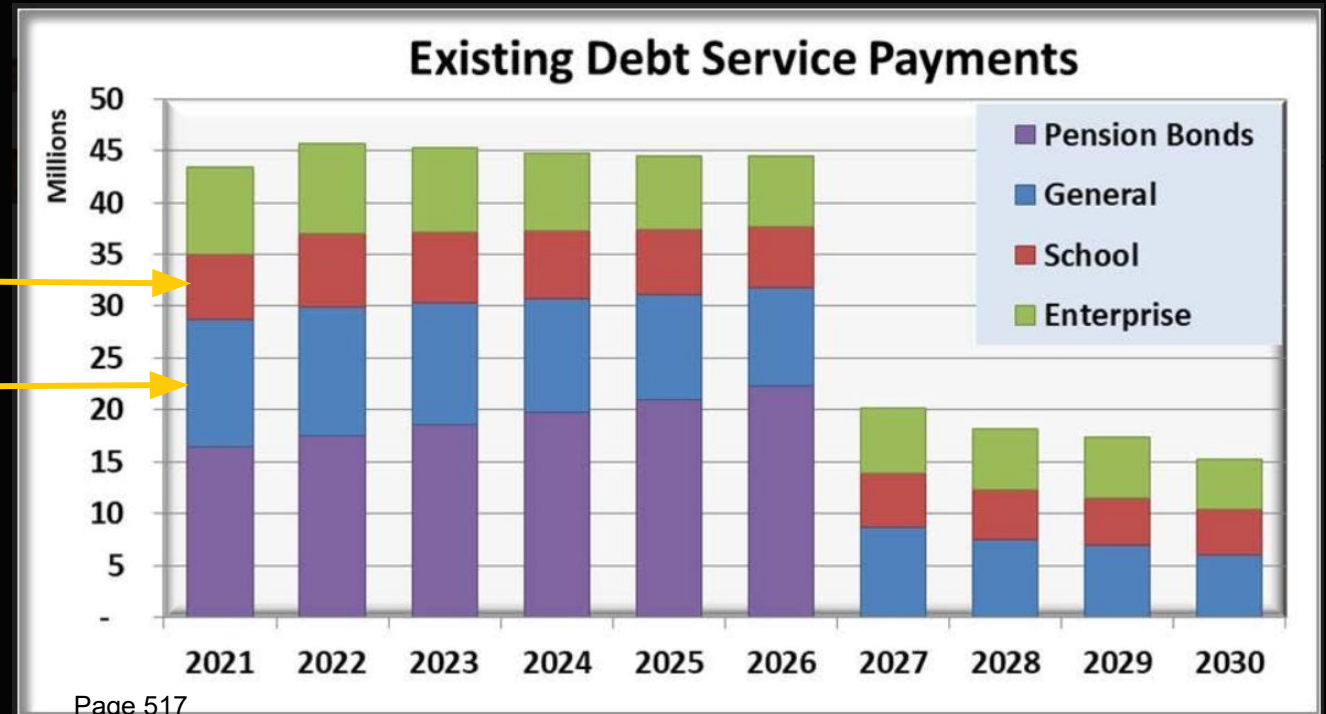

CIP Financing in Portland / CIP Borrowing Size and Impact on Property Tax Rates

- Each year the City retires older debt related to past CIP borrowings (debt that was issued 10 or 20 years ago), and therefore can issue new debt in its place without increasing overall debt service costs to the City related to CIP.
- We typically set the annual CIP target size to ensure no increase to property tax rates related to CIP debt service.





- **FY23 Existing debt service = \$28.0M**
- **FY24 Existing debt service = \$27.2M**
- **The \$800k decrease in existing debt service is the initial target that is available to fill with our FY24 CIP. For every \$1M of new debt we issue that creates \$90k of new debt service in Year 1.**
- **Assuming we only issued 20 year bonds, our CIP could be approximately \$8.8M for FY24 (\$800k / \$90k per \$1M = \$8.8M).**

Capital Improvement Plan: Financing Example



Assume the CIP target size is set at \$10M to protect property tax rate (i.e. City budget can take on \$800k in debt service without increasing property tax rate based on debt being retired).

Let's further assume as part of the \$10M CIP plan the City is recommending purchasing a new fire engine at an estimated \$1M cost taking up 10% of CIP target size.

The City is required to pay in full for most vehicles on delivery, but can manage the ongoing cost by issuing bonds in the total amount of the CIP. The City would pay the 3rd party vendor \$1M using our bond proceeds, and the only ongoing operating budget costs would be the \$90k in annual debt service for the next 20 years.

\$90k of expense on \$1M of new debt is approximately \$0.01 on the mill rate (tax rate) for 20 years which is a lower mill rate impact than \$1M of cash / operating budget expense would be equivalent to a one time mill rate increase of approximately \$0.12.

Capital Improvement Plan - Financing

- In recent years the City has also more aggressively pursued alternative funding sources to increase the impact of our annual CIP while maintaining the same responsible impacts to the property tax rate and utility rates.
- These alternative funding sources have included tens of millions of dollars in matching funds from the State of Maine and Federal Government, use of prior year surplus fund balance / cash reserves, use of savings from prior year CIP projects completed under budget, private donations from individuals and corporations, TIF revenues, grants, CDBG funding, impact fees, asset forfeiture funds, and special revenues including Merrill ticket surcharges and cruise ship passenger surcharges.
- Projects which include significant 3rd party funding / matching funds typically are more likely to be funded in the CIP.

Capital Improvement Plan: Sources of Financing Capital Expenditures

Capital Improvement Plan - Financing With Fund Balance / Cash Reserves

- We recommended use of surplus fund balance again in FY24 to support the CIP and provide tax stabilization / mill rate relief via using reserves to create expenditure reductions. The use of fund balance rather than issuing debt to fund CIP reduces debt service expenditures in future budgets.
- The tax stabilization is spread over 10-20 years rather than just a single year and the amount of the savings ends up being larger over time due to the elimination of interest payments.

Capital Improvement Plan - Use of Operating Revenues (Current Revenues)

- The City of Portland only uses operating budget revenues (current revenues) for Capital Planning for smaller CIP projects (office renovations, smaller computers/technology purchases, occasional vehicles or large equipment).
- We consider using operating revenues for larger capital purchases if the operating revenue is one-time in nature (i.e. a large payment not expected to repeat itself over time).

Capital Improvement Plan - Intergovernmental Transfers (Grants / Federal / State)

- Large Federal grants are rare (applications are typically very competitive). Example: [The RAISE grant program](#) from Department of Transportation.
- Other smaller Federal or private grants for specific categories of asset (Airport Improvement Grants from the FAA, Homeland Security Grants etc)
- State funding for large transportation projects (mostly State maintained roads within a municipality) are also available annually require a City match (10-50%). These are usually pass through funds from the Federal government.
- Other smaller categories of State grants are available occasionally for specific types of assets (most recently for energy efficient vehicles / infrastructure).

Capital Improvement Plan - Private Donations / Trust Funds

- Rare to receive significant volume of private donations to augment our CIP process. Typically 1-2 projects per year have companion private donations.
- Recent examples include:
 - A urban park on Congress Street (Congress Square Park) - many small donations & some medium sized corporate donations
 - A library on one the City Islands (Peaks Island Library) - one large family donation
 - [A City owned skate park - many small donations solicited via a text to donate campaign](#)
- City also receives donations via trusts (typically received upon death of a resident for use in cemeteries and our City owned nursing facility)

Capital Improvement Plan - TIF Proceeds / Impact Fee Funds

- City has three “area TIF districts” where certain types of capital infrastructure improvements are considered to be eligible uses of TIF funds.

Tax Increment Financing (TIF) is a value capture revenue tool that uses taxes on future gains in real estate values to pay for new infrastructure improvements

“Infrastructure” is defined, but not limited to: traffic upgrades, public parking facilities, roadway improvements, lighting, sidewalks, water and sewer utilities, storm water management improvements and placing above ground overhead electric and telecommunications lines underground.

- City also utilizes an impact fee program [launched in 2018](#) which has collected nearly \$3M to date. Impact fees may be used on specific related projects only and are generally pooled to support larger projects.

Impact fees are charges paid by a proposed development to fund the cost of providing municipal facilities to serve that development. This idea is premised on the concept that when development occurs, it can bring many benefits, but it also affects the existing infrastructure around it by adding more cars, bikes, and pedestrians to the streets, increasing sewer flows into City systems, and infusing additional visitors into the City's parks and open spaces. In order to accommodate this growth in demand, these facilities require additional capital investment.

Capital Improvement Plan - Public Private Partnerships (PPP)

Public-Private Partnership Pros and Cons

Benefits



Better infrastructure solutions than an initiative that is wholly public or wholly private.



Faster project completions and reduced delays on infrastructure projects.



ROI, might be greater than projects with traditional, all-private or all-government fulfillment.



Risks are fully appraised early on to determine project feasibility.

Disadvantages



Can increase government costs.



Limit the competitiveness required for cost-effective partnering.



Profits of the projects can vary depending on the assumed risk, the level of competition, and the complexity and scope of the project.



If the expertise in the partnership lies heavily on the private side, the government is at an inherent disadvantage.

Congress Square Redesign Description

Congress Square Redesign is a large-scale renovation of a major public open space and the encompassing intersection at the confluence of Congress, Free and High Streets. Located in not only a historically dense area of the peninsula, in terms of people, institutions, and businesses, the neighborhoods immediately adjacent are growing quickly, with nearly 2,500 new housing units approved since 2010, hundreds of which were added just within the last five years, with more approved to come.

The new design includes drastically improved ADA (Americans with Disabilities Act) access, landscaping, seating, storage for park events and maintenance, space to accommodate performances, play space for children, and critically, and in contrast to the current design, consideration of what elements make for successful urban parks.

Congress Square redesign includes two major phases:

- A) Phase A refers to the redesign of the Congress Square intersection, which includes the convergence of High Street, Free Street and Congress Street. This work is currently funded and underway. *Phase A is managed by the Department of Public Works.*
- B) Phase B refers to Design and construction of the Congress Square open spaces, which include PMA Plaza and Congress Square Park. *Phase B is managed by the Department of Planning & Urban Development.*

Both of these phases have been designed together and are complementary. Phase A by necessity precedes Phase B, which is designed to seamlessly mesh with the roadway improvements. This memo and CIP request are in regard to the Park redesign.

Previous year's CIPs have allocated funding for this project in installments in order to spread the expense over multiple years. This year's CIP request is the third and final installment needed to begin construction. This request for funding for Congress

Square would help conclude a long-planned and ultimately transformative public space project.

Below is an overview of the funding history, the current CIP request, and background on the history of the project.

Planning & Engagement History

The redesign of the intersection, including the park space, other adjacent public spaces, and the intersection right-of-way, has been designed as a whole to work together, though divided into 2 phases – 1) the redesign of the intersection ROW (Phase A) is a precursor to the park overhaul and is currently under construction, and 2) the public spaces of the square (Phase B) and the plaza in front of PMA. Like nearly all of the City's

initiatives to improve the public realm, the resource exists now in some form, but is not functioning as it should be or in a way that advances city goals. The streets that make up the intersection could have continued to function as they were, with no intervention, but the decision to invest in changes to it was guided by the need to have it be a more welcoming public square, and be safer and more sustainable for all modes of travel particularly pedestrians. This extends also to other streetscape initiatives, such as Franklin Street, Libbytown, Woodford's Corner and other Forest Avenue improvements underway, which each include substantial public space improvements that go beyond the movement of traffic and into the other sorts of public improvements that successful public spaces depend on to be successful. Redesigning Woodford's Corner, for instance, included hundreds of thousands of dollars of investments "behind the curb", outside of the travel lane right-of-way (ROW), to help improve the public spaces within the sidewalk area, from benches to lighting to public art to plantings, which in turn is improved for safety, local businesses (several new ones having opened in the vicinity since these public realm investments), and the fostering of a distinct place.

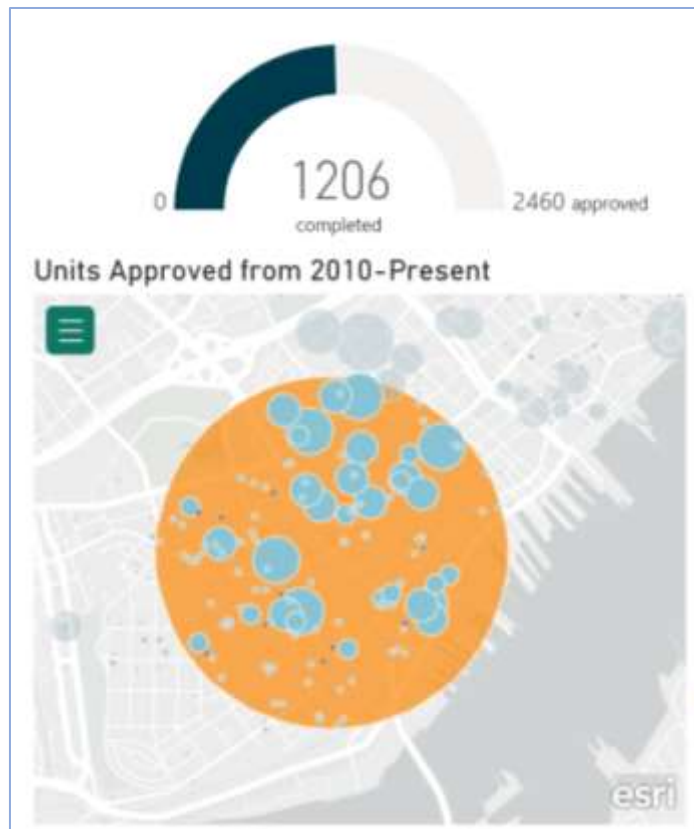


Figure 1, Housing Approved and Completed w/in 1/2 mile of Congress Sq. 2010 - 2024

Congress Square is unique in the size and primacy of the public spaces in relationship to the traffic of the intersection, and for the long recognized need for park improvements that have driven the project as a whole, making it primarily a project of redesigning the public space, including traffic and safety needs. This project has had a high level of community interest and participation – neighborhood organizations, residents, nonprofits, arts organizations, Friends of Congress Square, and the business community have worked tirelessly with the City of Portland for many years to develop and help implement the vision for a redesigned and invigorated square. As a phased project planned since 2014, and preceded by years of participatory planning efforts prior to that, there is tremendous impetus – in terms of substantial fundraising efforts of Friends of Congress Square, the completion of the Phase B construction drawings, the designed and funded art installation, and the complementary intersection redesign currently under construction – to complete this long strived for remaking of this crucial public space.

The intersection and its public spaces [have undergone many physical changes](#) over the years to accommodate the needs of the changing city. The park, initially called Congress Square Plaza, dates back

to the early 1980s as a result of a 1979 federal UDAG grant for distressed urban areas, and the park shows the mark of 1970s design approaches to public spaces.

A selection of milestones in efforts to remake the square are below:

- 2008 the [Congress Square Redesign Study Group](#) is created by the City Council, with two Council members included. In early communications about the square it's noted that the City of Portland had long "long planned to renovate and improve Congress Square Plaza".
- 2011 Rockbridge Capital, new owners of the Eastland Hotel, approached the Study Group with a proposal to redevelop the majority of the area of Congress Square Plaza into a new hotel ballroom. Noting that public space was a scarce and valuable resource in downtown Portland, the Study Group affirmed that it was important to retain the plaza as open space, rather than relinquishing it to a new private building.

After further discussions with Rockbridge Capital, there was consideration of a plan to allow a portion of the plaza to be developed, provided that project contributed to a redesign of the remaining space. The principles highlighted to guide future change included the need to prioritize excellent urban design, enhanced public open space (including intersection and transportation improvements), incorporation of public art, and contracting with quality design and engineering consultant team to inform the changes.

Early in Committee deliberations, there was intense public opinion for and against leveraging the private investment and partial privatization of the space to help redesign the park, with dozens of pages of comments pouring in for a single meeting. However, it was only the mechanism for how the space was redesigned that divided opinion, with widespread agreement that the park needed investment and change to make it a successful space.

- 2012 Congress Square Plaza property disposition is deliberated by the City Council's Housing and Community Development Committee.
- 2012 Portland Public Art Committee sets aside funding toward a public art installation for the square.
- 2013 [Friends of Congress Square Park](#) forms.
- 2013 a proposal is heard by the Council's Housing and Community Development Committee, for Rockland Capital to contribute funding toward design services that would incorporate a hotel event space, as well as an enhanced (but smaller) public plaza.
- 2013 [City Council votes on disposition of the property](#) in September of that year, with requirements for redesigning a portion of the space.

- 2014 Citizen referendum held, and voters approve a block of the sale of the property, as well as changes to the City's code that changed the procedure for any sale or transfer of its public parks.
- 2014 new redesign efforts established following referendum results, including a statement of values and strategy for the space going forward.
- 2016 more than 100 design proposals are received in response to a City design RFQ for the square. Three days of public design forums are held in May for viewing of design and public art finalists. [WRT](#) and [Sarah Sze](#) are both selected. Sebago Technics joins the project as the engineering firm.
- 2018, Historic Preservation Board, Land Bank Commission and Parks Commission all review the park designs.
- 2018 National Endowment for the Arts grant is received.
- 2019 MaineDOT commits funding toward intersection portion of the project.
- 2020 Intersection drawings completed.
- 2021 [Public Forum](#) with update on park progress and a lecture by artist Sarah Sze on the value of public art for the square.
- 2022 Park construction drawings completed.
- 2022 Part I of construction funding approved.
- 2023 Part II of construction funding approved.

Summary of CIP Funding Request

This year's CIP request for the Congress Square Redesign project (Phase B) is for \$750,000, which in addition to the past two year's funding amounts of \$900,000 and \$700,000, is a total cumulative funding request of \$2,350,000 spread across three budget cycles. This phase is highly leveraged by funding contributions by Friends of Congress Square. Design Development was completed in 2018. Construction Documents were completed in 2022, and revised cost estimates were completed in 2023.

In addition to being planned and designed together, both phase A&B are being significantly aided through other funding sources, including \$1 million in funding from MaineDOT for the intersection. Other funding sources provided by Friends of Congress Square to help complete the redesign of the square's public open spaces, including significant contributions toward a public art installation long planned for the park (the public art component is not funded through the CIP process, though it has received some funding from Portland's Public Art Committee), as well as contributions to Phase B construction.

Conclusion

Upon completion it would better serve the thousands of people passing through on foot, bicycle, bus and car, as well as spending time in Congress Square every day, including residents, visitors, commuters, performers, vendors, and employees of local businesses in this heart of the city. The square serves as an important civic space today, but its current form brings challenges and limitations; an improved design for the 21st c. would not only be a boon to current users of this public space, but will become a more equitable and inclusive public space by virtue of the accessibility and safety improvements it would bring, and new features such as artwork and play spaces for children. Completion of this initiative, built on public input, prior City financial investment, countless hours of dedicated staff time, and great effort of City Committees, Boards and the City Council over more than a decade, will be a great civic and cultural achievement for the City of Portland.

**ORDER AUTHORIZING GENERAL OBLIGATION BONDS
TO FINANCE A PORTION OF THE CITY'S FISCAL YEAR FY25 CAPITAL
IMPROVEMENT PROGRAM IN AN AMOUNT NOT TO EXCEED \$19,040,000**

FOLLOWING a public hearing of the City Council of the City of Portland, Maine, held upon due notice pursuant to Article VII, Section 9 of the City Charter, **IT IS HEREBY ORDERED THAT:**

There is hereby authorized and approved a borrowing by the City of Portland in the aggregate principal amount not to exceed Nineteen Million Forty Thousand Dollars (\$19,040,000), such borrowing to be evidenced by the City's general obligation bonds (the "Bonds") and temporary notes in anticipation thereof (the "Notes), to finance the items identified in the City's FY25 Capital Improvement Program attached hereto as Exhibit A and all other costs (as defined herein) related and ancillary thereto (the "Projects").

BE IT FURTHER ORDERED:

1. That the Bonds and Notes shall be executed in the name of and on behalf of the City by the Director of Finance and the Mayor, either or both of whose signatures may be by facsimile to the extent permitted by law, and shall bear the City seal thereon, attested by its Clerk.

2. That the Director of Finance is hereby authorized, in the name of and on behalf of the City of Portland, to prepare, issue, and sell such Bonds and Notes through a public offering (on a competitive or negotiated basis or a combination thereof) or a private placement, or a combination thereof, and such Bonds may be issued in serial form or as term bonds, or some combination thereof, may be issued as physical certificates or in book-entry form pursuant to the Depository Trust Company Book-Entry Only System, and may issued at one time or from time to time, as one or more separate bond issues, all as the Director of Finance shall determine to be appropriate in his sole discretion.

3. That the Director of Finance is hereby authorized, in the name of and on behalf of the City, to establish, determine and approve the form, dates, maturities (with the last maturity not to exceed the maximum term permitted by law), denominations, interest rates, places of payment, provisions for early redemption, with or without a premium, prior to the stated maturity date(s), and all other details, including the timing and manner of their sale and award, such establishment, determination and approval to be conclusively evidenced by the execution thereof.

4. That the Director of Finance is hereby authorized, in the name of and on behalf of the City, to do or cause to be done all such acts and things, including to select a financial advisor, underwriter, or paying agent /registrar for such Bonds and Notes, and to execute, deliver and approve all contracts, loan agreements, investment agreements, tax compliance agreements or arbitrage certificates, closing certificates, instruments, Preliminary Official Statement, Official Statement or other offering document, a Letter of Representation necessary to qualify the Bonds or Notes for the Depository Trust Company Book-Entry Only System, a continuing disclosure undertaking pursuant to Securities and

Exchange Commission Rule 15c2-12 and any other documents or agreements (the “Bond Documents”) as may be necessary or advisable, in connection with the financing of the Projects and the offering, sale, issuance, and delivery of the Bonds and Notes, and the investment of the proceeds thereof, which Bond Documents shall be in such form and contain such terms and provisions including, without limitation, the waiving of the District’s sovereign or governmental immunity with respect to the enforceability of any of the forgoing, which waiver of sovereign or governmental immunity is hereby authorized, confirmed and approved, and such other details as he shall establish, determine and approve, such establishment, determination and approval to be conclusively evidenced by the execution thereof.

5. That if the Bonds or Notes, or any part of them, are issued on a tax-exempt basis, the Director of Finance is hereby authorized, in the name of and on behalf of the City, to covenant and certify that:

- (A) No part of the Projects shall be used directly or indirectly, in a manner that would cause the Bonds or Notes to be “private activity bonds” within the meaning of Section 141 of the Internal Revenue Code of 1986, as amended (the “Code”), and that no part of the proceeds of the Bonds and Notes shall be used directly or indirectly to acquire any securities or obligations, the acquisition of which or the investment yield on which would cause such Bonds or Notes to be “arbitrage bonds” within the meaning of Section 148 of the Code; and
- (B) The City will file any required reports and take any other action that may be necessary to insure that interest on the Bonds and Notes will remain exempt from federal income taxation, and that the City will refrain from any action that would cause interest on the Bonds or Notes to be subject to federal income taxation.

6. That the term “cost” or “costs” as used herein and applied to the Projects, or any portion thereof, includes, but is not limited to (1) the cost to design, acquire, construct, renovate, improve, furnish and equip the Projects, or any portion thereof; (2) the cost of land, easements and other real property interests, landscaping and site preparation, including demolition and environmental remediation work on any existing building or structure and on the property where the Projects are located, utility extensions and site improvements, and all appurtenances and other fixtures, facilities, buildings and structures either on, above, or under the ground which are used or usable in connection with the Project; (3) the cost of feasibility studies, surveys, environmental studies and assessments, engineering, plans and specifications, legal and other professional services associated with the Project; (4) issuance costs, including premiums for insurance, capitalized interest and other fees and expenses relating to the issuance and delivery of the Bonds and Note.

7. That if the actual cost of any Project differs from the estimated cost on the attached Exhibit A, whether due to completion, delay or abandonment of such Project or for any other reason, the Director of Finance is hereby authorized, in the name of and on behalf of the City, in his discretion, to reallocate proceeds of the Bonds and Notes to any other Project listed on the attached Exhibit A, or to any other project or improvement that the City Council has approved or may in the future approve as part of the City’s annual capital improvement plan.

8. That if the Director of Finance, Mayor or Clerk are for any reason unavailable to approve and execute the Bonds or Notes or any other Bond Document necessary or convenient to the issuance, execution and delivery of the Bonds or Notes, the person or persons then acting in such capacity,

whether on an interim or acting basis, as an assistant, a deputy, or otherwise, is authorized, in the name of and on behalf of the City, to act for such official with the same force and effect as if such official had performed such act.

9. That if any of the officers or officials of the City who have signed or sealed the Bonds or Notes shall cease to be such officers or officials before the Bonds or Notes so signed and sealed shall have been actually authenticated or delivered by the City, such Bonds or Notes nevertheless may be authenticated, issued, and delivered with the same force and effect as though the person or persons who signed or sealed such Bonds or Notes had not ceased to be such officer or official; and also any such bonds or notes may be signed and sealed on behalf of the City by those persons who, at the actual date of the execution of such Bonds or Notes, shall be the proper officers and officials of the City, although at the nominal date of such Bonds or Notes any such person shall not have been such officer or official.

10. That to the extent not payable from other funds, an amount sufficient for the payment of the annual payments of principal and interest on the Bonds or any Notes issued hereunder shall be included in the tax levy of each year until the debt represented by said Bonds or Notes is extinguished.

11. That if any of the Bonds or Notes are issued through the State of Maine Clean Water Revolving Loan Fund (CWSRF), the following resolutions required by Section C(4)(e) of the CWSRF Rules, Chapter 595 (the “SRF Regulations”), administered by the Department of Environmental Protection and the Maine Municipal Bond Bank (the “Bond Bank”), be and hereby are adopted:

- a. That a Project Account shall be created for the Projects which shall be separate from all other accounts of the City. If operating revenues are to be used to retire the debt, a sub-account will be established;
- b. That the Project Account shall be maintained in accordance with standards set forth by the Bond Bank and in accordance with generally accepted government account standards;
- c. That a final accounting shall be made to the Bond Bank of the total cost of each Project upon completion of the Project performance certification as set out in Section G(3) of the SRF Regulations and the City acknowledges that the Bond Bank reserves the right at its sole discretion to be provided with a cost certification of the Project as built;
- d. That an annual audit of the City, prepared by a certified public accountant or licensed public accountant be provided to the Bond Bank for the term of the loan;
- e. That the City shall maintain insurance coverage on the Projects in an amount adequate to protect the Bond Bank’s interest for the term of the loan with the Bond Bank named as loss payee;
- f. That the City will comply with any special conditions specified by the Department of Environmental Protection’s environmental determination until all financial obligations to the State have been discharged;
- g. That the City certify to the Bond Bank that it has secured all permits, licenses and approvals necessary and that it has a dedicated source of revenue for repayment;

- h. That the City establish a rate, charge or assessment schedule in order to pay principal and interest. Such rate change or schedule shall provide total operations and debt service coverage at a level at which the coverage for the Bond Bank is sufficient;
- i. That the City must demonstrate the ability to pay reasonably anticipated costs of operating and maintaining the financed Project; and
- j. That the City abide by the SRF Regulations, as revised and amended and relevant State statutes of the State of Maine.

12. That during the term any of the Bonds (or bonds issued to refund such Bonds) are outstanding, the Director of Finance is hereby authorized, in the name of and on behalf of the City, to issue and deliver refunding bonds to refund some or all of the Bonds then outstanding, and to establish, determine and approve the time of the sale, award and settlement of such refunding bonds, the form, date, maturities (not to exceed the maximum term permitted by law), denominations, interest rates, payment dates, and all other details of such refunding bonds, and to provide that any of such refunding bonds may be made subject to call for redemption, with or without premium, before their stated maturity dates, such establishment, determination and approval to be conclusively evidenced by his execution thereof, and to execute and deliver, in the name of and on behalf of the City, such additional Bond Documents as may be reasonable or necessary with respect to such refunding, and each refunding bond issued hereunder shall be signed in the same manner as the Bonds.

13. That the City may pay certain costs of the Projects prior to the issuance of the Bonds and Notes (referred to as "original expenditures"); to that end, the City hereby declares its official intent to reimburse itself for such original expenditures from the proceeds of such bonds and notes, and this Resolution shall constitute the City's declaration of official intent pursuant to Treasury Regulation §1.150-2.

IT IS HEREBY ORDERED THAT

1. Subject to paragraph 2 and 3 below, the sum of \$28,510,000, plus the investment earnings and original issue premium arising, if any, associated with issuance of the City's general obligation bonds, be and hereby is appropriated to finance the projects more particularly described in the project list for the City's FY25 Capital Improvement Program attached hereto as Exhibit A (the "FY25 CIP Project List"), as follows:
 - a. The sum of \$12,100,000 is appropriated from the proceeds of the City's general obligation bonds to be authorized by the City Council to finance a portion of the costs of the General Fund Projects included in the FY25 CIP Project List;
 - b. The sum of \$6,940,000 is appropriated from the proceeds of the City's general obligation bonds to be authorized by the City Council to finance a portion of the costs of the Enterprise Fund Projects included in the FY25 CIP Project List;
 - c. An additional amount not to exceed \$9,470,000 is appropriated as follows:
 - i. An amount not to exceed \$8,960,000 is appropriated from the City's Assigned Surplus Fund Balance – Capital Improvement to finance a portion of the projects so indicated in the FY25 CIP Project List;
 - ii. An amount not to exceed \$110,000 is reallocated and appropriated from unspent proceeds of the City's prior FY24 CIP General Obligation Bonds to finance a portion of the projects so indicated in the FY25 CIP Project List;
 - iii. An amount not to exceed \$400,000 is appropriated from the City's Transportation Impact Fees, to finance a portion of the projects so indicated in the FY25 CIP Project List.
2. The appropriations set forth in paragraphs 1(a) & (b) above are and shall be contingent upon the authorization and issuance of the City's general obligation bonds for such purposes (the amount appropriated in said paragraph 1(a) & (b) to be adjusted to reflect the principal amount of bonds so authorized), and shall include issuance costs for such bonds (or notes in anticipation thereof). The foregoing appropriations, in addition to the stated amount, shall also include any investment earnings or original issue premium associated with such bonds (or notes in anticipation thereof).

3. If the actual cost of any project included in the FY25 CIP Project List differs from the estimated cost on the attached Exhibit A, whether due to completion, delay or abandonment of the Project or for any other reason, the Director of Finance is authorized, in his discretion, to reallocate proceeds of the bonds issued therefore or the other funds appropriated therefore to any other project listed on the FY25 CIP Project List or to any project the City Council has approved or may in the future approve as part of the City's annual capital improvement plan.

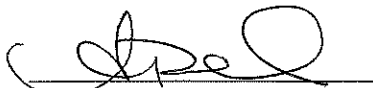

Dear Chair Trevorrow and Members of the Finance Committee,

CHOM is pleased to provide a letter of support for the City of Portland Planning Department's request for \$750,000 in CIP funds to facilitate the reconstruction of Congress Square and the PMA Plaza as Phase Two of their Congress Square Redesign project.

As a low-income housing developer housing more than 1,250 of Maine's most vulnerable people, and Maine's largest provider of supportive housing for homeless populations in the state, CHOM understands the critical role that high-quality and well-maintained public spaces play in promoting the physical and mental well-being of Maine residents. CHOM creates inclusive communities and is rooted on the belief that stable service-enriched housing has the power to transform lives. Likewise, Mainers need inclusive, vibrant, and accessible public spaces that provide opportunities for social connections and foster a sense of belonging.

Congress Square sits in Portland's most densely populated and diverse neighborhood. The reconstruction will transform a vehicle-dominated, inaccessible area into a world-class urban space that was informed by an extensive community-driven process over a decade in the making. The improvements will enhance opportunities for social connections and foster a sense of neighborhood pride and belonging in one of Portland's densest urban neighborhoods. CHOM currently owns 68 units within a quarter mile of Congress Square, with another 95 units under development (expected to open in August and October of 2024). Nearly half of the residents in the existing two buildings were homeless upon entry. Along with CHOM's properties, dozens of other low-income housing rental properties are within walking distance to Congress Square. Most of these tenants do not have backyards or porches, or cars get out of the city. Many of them rely on Congress Square as their outdoor living room, a place where they can socialize with neighbors, be in sunshine and breathe fresh air, and enjoy the free arts and cultural programming provided by Friends of Congress Square Park (FoCSP). In fact, several of CHOM's tenants are active volunteers in FoCSP's Park Steward program which has helped them to feel an even stronger sense of belonging in this beloved community open public space.

For the homeless population in Portland, Congress Square provides a welcome respite. FoCSP has worked with neighborhood non-profits, such as CHOM, to ensure that everyone feels welcome and safe in the space. One unhoused member of our community was such a park regular, he became an active volunteer and later become employed by FoCSP to help with park maintenance. This individual eventually became a tenant at one of CHOM's nearby buildings. After nearly a decade of homelessness, he now finds himself at home in two supportive and inclusive communities.

Despite the community-led placemaking which has created a sense of vibrancy in the Square, the physical infrastructure is failing our community. The intersection is car-dominated and dangerous for pedestrians. The primary entrance to the park that sits on one side of the



Square is a set of 5 steps, creating a physical barrier for neighbors with mobility issues or parents with strollers. The accessible entrances are tucked out of the way making them difficult to find. The back corner of the park slopes down and away from the street creating an unsafe and unwelcoming area. Finally, there are only a few permanent benches so when FoCSP removes its cafe tables and benches for the winter season, there is nowhere to sit for nearly half the year.

The redesign has been a community-led process over 10 years in the making. Great effort has been made by the City of Portland to include a diverse group of stakeholders in the design process to ensure the design fulfills the community's desire for this critical public space. The design will create a year-round accessible respite for all members of our community with permanent seat walls and benches, year-round horticulture, improved lighting, and gradual pathways that easily allow everyone to enter and pass through the area. In a recent meeting, the design team even noted that the benches that were selected would not have metal armrests to interfere with reclining. While this may seem a small detail, many public spaces are now designed to discourage people experiencing homelessness from using the spaces, including installing anti-sleep benches with large metal armrests.

The Congress Square Redesign project is rooted in the belief that the Square belongs to everyone. As such, the City of Portland has embraced an inclusive approach to the project, from including a diverse group of voices in the design process to ensuring the physical space will welcome all people, including our unhoused neighbors and friends. CHOM is proud to support the project, and we hope you will too.

As the Executive Director of Friends of Congress Square Park, I am keenly aware of the value a vibrant and healthy public space -- especially this one -- holds for the well-being and social connectedness of its surrounding community. This, of course, is particularly pronounced at a time when the U.S. Surgeon General has declared loneliness an epidemic.

The current design of the space itself, however, leaves much to be desired. As you know, the Planning and Urban Development Department is requesting \$750,000 in Portland's Capital Improvement Plan with the funds being used for completion of the Congress Square Redesign project.

The initial phase of construction began 2 years ago, and I had a birds eye view (3rd floor Hay Building, 594 Congress Street) of the work that Gordon Construction was performing. Not only did they do a poor job, but they did not complete the first phase of the project despite running 4 months over the expected completion time. They were forced to open High Street despite the fact the brick work and planters were not completed.

The city approved the plan to remove frontage from the Hay Building, add frontage to the PMA plaza while constructing a new traffic pattern for High, Free and Congress Streets. After removing bricks, granite blocks, and trees, the first phase of the construction resulted in a large PMA plaza with unsightly asphalt (not bricks as depicted in the Redesign Plan) and poorly constructed granite planters which collapsed and have remained empty for the past 1 ½ years. The result of the first phase of construction has left Congress Square in worse shape, both visually and functionally without a working Free Street pedestrian crosswalk sign.

Congress Square is a vibrant part of our city, community involvement in the park is second to none in the city.

The decision to redesign Congress Square has been a decade in the making, with the hopes of transforming the vehicle dominated intersection in the heart of the Arts District, into world class urban space fostering neighborhood pride for those living and working in the area. In fact, private dollars have already been raised by The Friends of Congress Square Park aiding in the project. At the present time Congress Square is hurting, businesses are leaving with several storefronts for lease and businesses even boarding up their frontage when not open.

I understand the city has many projects which need to be funded such as public bathrooms, homeless housing, etc, and I am in favor of funding those projects, however, the city should finish the project they started.

Funding for this project has broad support from the neighborhood, local businesses as well as the City Manager. Please consider approving the request in the Capital Improvement Plan budget for \$750,000 to facilitate the completion of the Congress Square Park Redesign.

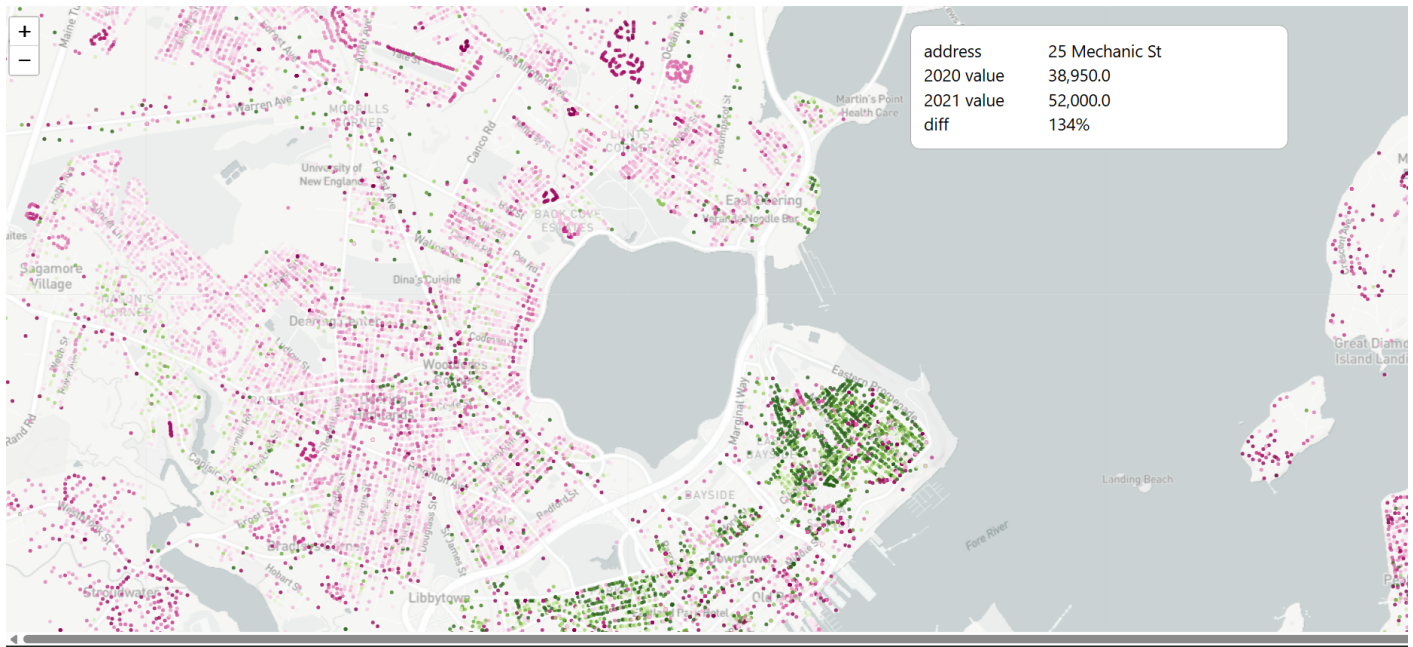

2. Why is the City budget having to pay for Public School Capital Improvement Project (CIP) requests?

- For example, the City budget is made up of only 43% of the Mill rate to generate property taxes while the Public School System gets 51% of the mill rate revenue generate in property taxes has to have.
- Why aren't these Public School CIP requests coming from the Public school budget side which takes 53% revenue of property taxes, in order to pay for their own CIP improvements?

3. Park & Rec CIP Requests for East Prom Food Truck Electricity

- Many Eastern Prom residents were NOT in favor of installing electrical infrastructure inside this popular and Historic Park. In fact, this specific CIP proposal was NOT favored by the Munjoy Hill Neighborhood Organization as they sent an email in July 2023 as a result.

- In addition, is there any documented evidence from the Federal Historic Landmark regulations that this is an acceptable project?
- Parks & Rec budget continues to not allocate anything to Eastern Prom regarding building or maintaining existing park infrastructure for community experiences unless it seems to be a food park related expense for private commercial businesses in which the taxpayers have to pay for.

I hope these concerns can be addressed in tonight's CIP discussion.

Hi Mayor Snyder and City Councilors,

While I don't have an issue with the data presented here, I do have an issue with how it has been interpreted. The sole focus of the article is based on the tax side of the revaluation, not the valuation side, and it seems to infer that the changes were implemented in some nefarious scheme to increase rents and taxes on families while giving "tax cuts" to commercial properties. This is simply not the case.

The goal of any revaluation is to value property at 100% of Fair Market Value (FMV). As you know, most every assessed value increased in the revaluation and it's the level of that increase that determined what the outcome of the tax change was for each parcel. Prior to the revaluation, multi-family properties, as a class, were only assessed at 57% of their FMV. This was the lowest ratio of any property class in the entire City. Class A office buildings were assessed at 80% FMV while the entire commercial class of properties as a whole was 72%. Based on this data, multi-family properties were grossly under assessed, and offices and other commercial properties were only slightly to moderately under assessed. While both multi-family and commercial properties saw their assessed values increase, the multi-family properties increased at a much higher percentage in order to get them to 100% FMV. This resulted in tax increases for many. Of course, it is important to remember that for 10-12 years prior, these properties were well under-assessed and paying less than their fair share of taxes.

The article specifically highlights the tax decrease for the UNUM parcels and others. While the taxes for the UNUM parcels may have decreased \$248,000 from the year before, their assessed value increased over \$85 million or 65%. Island properties saw valuation increases of 53%, on average. This is less than the overall City average increase, and thus, lower taxes resulted for those whose increases were below the City average increase of 77%. Most importantly, these new valuations are reflective of their Fair Market Value as of 4/1/2021.

Just like with any revaluation, there was a tax shift between the Residential and Commercial tax bases. Pre-reval, I had estimated that there was going to be a 2% to 4% tax shift from Commercial to Residential because we knew that the Residential class of properties were far more under-assessed than the Commercial class of properties. The outcome turned out to be only a 1% shift, although after all appeals are settled, it could be closer to a 2% shift. We have 20,560 residential parcels that make up \$8.3B of the tax base and just 2,724 commercial parcels that make up \$6.3B of the tax base.

The article outlines a few examples of property tax relief, but the key point missing from this analysis is that the City Council has no authority to enact additional tax exemptions, tax relief programs or tax law reforms that are not outlined in state law or approved by the state legislature. I'm all for a robust debate and discussion on various property tax reform measures (there are some good ideas out there to do just that), but that debate will need to happen in Augusta. Changes to the current property tax structure require changes to state law and/or the state constitution.

Finally, I'll say again that from the statistical measures that are currently mandated by law, this revaluation was a success. We are back in full compliance with what the law requires. While we can say we were at 100% of FMV as of the 4/1/21 (FY22) assessment date, current data shows we may fall to 92% for the 4/1/22 (FY23) assessment date. Sale prices in every sector are continuing to increase with the largest increases in the Residential sector. As a result, we will need to think about another valuation update for FY25 or FY26. For now, we will be continuing to focus on the over 200 formal pending appeals from this revaluation process. The deadline to appeal is March 11, 2022 and we expect many more to be filed before then.

I have attached a document showing the valuation totals and breakdown for FY22. I am happy to answer any additional questions that you may have. I will also be responding directly to Mr. MilNeil.

Honorable Councilors,

Over the rainy weekend I took some time to analyze the city's new tax assessment database in some detail, and compare tax rates paid by various classes of property owner in 2021, after the revaluation, versus 2020.

What I found should give the Council some cause for concern. There's strong evidence that the revaluation gave tax cuts to wealthy investor-owned corporations like Unitil and CMP at the expense of residents, particularly renters.

After last year's revaluation:

- Taxes on multifamily residential properties – i.e. apartment buildings – collectively went up by \$8.8 million (a 29% increase). Given the inelasticity of Portland's rental market, it's probable that almost all of that tax increase got passed on to tenants in the form of higher rents.
- Meanwhile, wealthier classes of property owners were more likely to get tax breaks:
 - Owners of vacation homes (mostly on the islands), are collectively paying the city \$570K less this year than in 2020, a 15% tax cut compared to 2020.
 - Taxes on office buildings went down by 3.3%, on average.
 - Residential condo owners got, on average, a 10.4% tax cut.
 - CMP and Unitil each got a \$1.1 million tax cut (42% less than their 2020 tax bills) on their properties in the city.

If you read through to the end, I offer some thoughts on how the Council could shift more of the tax burden off of residents – particularly renters – and back onto investor-owned commercial properties, which can afford and deserve to pay more for our city's services. Needless to say, I think this would be a politically popular idea among Portland voters.

The idea of a property tax is attractive in principle: owners of more valuable properties should pay more for city services. But that concept breaks down for homeowners or small landlords who have a strong interest in not making themselves or their tenants homeless.

My home's value doubled on paper, but there's no way I can actually use that "wealth" because if I sell my house and cash out, I'll just need to pay someone else for a new place to live. If I own a 10% stake in an office building, or a second house on an island, on the other hand, those assets are easy to sell – and those are the properties that should bear more of our public taxation (they're also the properties that can afford to, after receiving a generous tax cut from Trump's 2017 corporate tax cuts).

Mayor Dion, Chair Trevorrow, and Members of the Portland City Council Finance Committee,

The Portland Regional Chamber of Commerce represents over 1,300 members in eight communities in Greater Portland, employing over 65,000 Mainers. Please accept our letter of strong support for the final funding included in the City Manager's proposed FY25 Capital Improvement Plan for the Congress Square Redesign Project. While we initially supported the plan a decade ago to have this parcel redesigned and programmed by the adjacent hotel, the voters of Portland rejected that plan, and the city made a commitment to undertake the redesign and associated costs in partnership with Maine DOT and the Friends of Congress Square Park. It is essential that the city honor that commitment with this final tranche of funding.

From an economic perspective, there has not been a more dangerous moment for the continued vitality of the Congress Street Corridor since the construction of the Maine Mall and the subsequent retreat of small businesses and foot traffic from our city's downtown core. Within the last several years since the onset of the pandemic, retail vacancies in the vicinity of this site have increased dramatically, and foot traffic has decreased. When this last happened in the 1970s, it took decades of work to reverse this trend through the addition of the Children's Museum and Theatre and the I.M. Pei building to the Portland Museum of Art Campus, the reinvigoration of the State Theatre, and the renovation of the Porteous Building in the 1990s to house the Maine College of Art and Design. It was only after these significant cultural and civic amenities were added to the corridor that businesses were again a sustainable enterprise. Similarly, this 21st century moment of retreat demands the addition to and transformation of this square and corridor to bring vitality and business growth back to the area. The completion of the significant efforts of the city, state, and private philanthropy to redesign Congress Square will go a long way towards this goal.

The team behind the redesign project has worked to transform the area into a public space with improved accessibility for all. All these improvements are in line with research showing that high quality public spaces create economic, social, and environmental value. We believe it is critical that a functional and attractive public space has a group of people who is committed to the ongoing upkeep and programming in the space. We appreciate the efforts of Friends of Congress Square Park (FoCSP) to provide amenities and organize over 150 free public events a year in the space. FoCSP's continued commitment to serve in this role after the redesign is important to the future of the space.

Our organization feels that improvements to and investment in Congress Square, both the park and the intersection, are a positive step in creating a dynamic and useful public space in the heart of Portland's Arts District. This redesign will be beneficial for businesses in the area and will prove necessary as Portland continues to grow.
