The Committee discussed the concerns about the potential funding gap with the expected loss of FEMA reimbursement for non-congregate sheltering.

Aaron Geyer provided an update on GA work in the City of Portland, and the high numbers of individuals presenting for General Assistance not only in Portland, but other municipalities throughout the state.
