A. Interpretation Appeal: ([ZBA-002053-2022](#))

110 Thames Street, owner PF One DevCo LLC, Tax Map 018, Block A, Lot 004, B-6 Mixed Use Zone: The owner is challenging the Permitting and Inspections Department's denial of building permit, #BLDC2022-02496, based on the fact that the applicant's computation of the occupant load does not meet the requirements of the IBC code. The owner requests that the Board approve the occupant load calculations of their Registered Design Professional and overturn the denial of the building permit. Representing the appeal are the owner's attorneys, Kurt Olafsen and Meredith Eilers.

B. Interpretation Appeal: ([ZBA-002056-2022](#))

110 Thames Street, lessee Sun Life Financial (US) Services Company, Tax Map 018, Block A, Lot 004, B-6 Mixed Use Zone: The lessee is challenging the Permitting and Inspections Department's denial of building permit, #BLDC2021-02424, based on the fact that the applicant's computation of the occupant load does not meet the requirements of the IBC code. The lessee requests that the Board find the City's interpretation of the relevant building code sections regarding occupancy load for modern office buildings incorrect and overturn the denial of the building permit. Representing the appeal are the lessee's attorney, Mary Costigan, and Donna Buck, architect at GastingerWalker.
